On 1 April 2019, I, Deputy St. John, responded to the Palm Coast Substation in reference to harassing phone calls.

Upon my arrival, I made contact with Luis Medeiros. Luis advised me that he wished to document text messages coming from "Dan Priotti" a known associate from the Palm Coast Contractor Board. Luis advised that since he has had been on the board when the board upheld a negative judgement against his business. Luis told me that the reason for notifying law enforcement today was because he requested the other party to stop contacting him. Stating "This is a private phone. And if you continue to send me messages, it will be considered harassment." After sending the message the suspect replied "Sue Me. As long as you sit on the contracting board you put together I will follow your business dealings and let you know the contracting laws you continue to think don't apply to you Because it obvious you don't know them to be signing orders from your seat on the contracting board, If I was you if resign immediately from your seat on the board. That seat should be for contractors in great standing who don't screw their subs by not paying them and breaking contracts in the middle of work because they won't go forward with out getting paid. All you have to do it make right what is wrong." Mr Medeiros said that the conversation took place yesterday afternoon and that there has been no contact since then. When I asked Mr Medeiros if he would like to pursue criminal harassment charges and he stated that he would only like to have a case report generated due to Mr Priotti making threatening statements regarding his status on the contractor review board.

Mr. Medeiros described Mr. Priotti as a male in a wheelchair late 30s early 40s in age who lives in the c section of Palm Coast and has a bald head.

Mr. Medeiros completed a sworn written statement that will be submitted to records in a timely manner. Mr Medeiros was also provided with a case card for future reference.
