



Witness(1)'s daughter is E.I. DOB: 01/02/13 (E.I victim child). Detective Vinci with the Flagler Beach Police Department was on scene in the building and asked Witness(1) to take a seat in the interview room. At 9:39 a.m. on January 10, 2020 Witness(1) and Detective Vinci began their interview and controlled cell

phone call with Mussack. The following statements were made:

Witness(1) made contact with Mussack via cell phone in Detective Vinci's presence. When Mussack answered the phone, Witness(1) asked, "You remember how you said I could just ask a couple questions and I'm not trying to like beat a dead horse I know you told me but that was it Lance? Like those two pictures, that was is right? Like you didn't touch her right?" Mussack replied, "What are you asking one more time? Yes! It'll never happen again. I don't even know why it happened in the fucking first place. Ummm..." Witness(1) asked again, "You didn't touch her though right?" Mussack replied, "No I would never touch her." Witness(1) replied, "So you just took the pictures and that was it right?" Mussack replied, "Yes, yes I would never touch her in a million fucking years. No way I would ever fucking do that to her." Witness(1) asked Mussack, "Do you think she knew? Is that why the other day she didn't want to sleep there?" Mussack replied, "No defiantly not, totally asleep. I don't know why she would say that. (loud sigh) It's just a fucked up situation. This is fucking ridiculous, I'm so sorry. I don't know what else to do. It's almost like I can't fucking make it right." Witness(1) interrupted Mussack and asked him, "And it was like how many times? Just tell me one last time before I go crazy. Was it only two times?" Mussack replied, "Yes. Yes, it was." Witness(1) then asked Mussack, "So it was the one I found on your phone that said the 29th before New Year's and it was the other one with the black sheet which you got so it must have been Monday?" Mussack stated, "I'm not sure but yes." Witness(1) stated, "I just don't understand why Lance." Mussack replied, "I don't know either." Witness(1) stated, "You tell me about your dad now about what he did to your sister but then why would you do it?" Mussack responded, "It's just always come back to haunt me. I try and get it off my shoulders." Mussack goes on to say, "I want to fucking jump off the bridge." Witness(1) advised Mussack that he needs to get help and then stated she had to go and hung up the phone. For further detail on the controlled call reference and see the recording.

At approximately 9:54 a.m. Witness(1) and Detective Vinci reenter the interview room for Witness(1)'s statement. Witness(1) advised on December 29, 2019 she picked up Lance Mussack's cell phone to take a funny picture of herself. Witness(1) opened Mussack's pictures and noticed a what appeared to be a young female or teenager female's vagina. Witness(1) advised she took a picture of the vagina with her phone and then put Mussack's cell phone down. Witness(1) described Mussack's cell phone as an iPhone in a black case with a red sticker. Witness(1) deleted the picture from her phone. The picture of the vagina on Mussack's phone has been bothering her for several days. On January 10, 2020 in the morning Witness(1) picks up Mussack's cell phone and attempts to find the photo again. While looking at the pictures Witness(1) notices that there have been more provocative and nude pictures taken with a time stamp on the pictures of January 6, 2020. In a few of the

pictures she noticed a custom made blanket from a family member, the black bed sheets and the back ground. Witness(1) advised that the bed sheets are from Mussack's bed. Witness(1) stated that Mussack just purchased those sheets a few days ago and the background was Mussacks residence at 600 Moody Lane. After looking at the photographs Witness(1) realized that the picture of the young girl's vagina and the other provocative and nude pictures was her 7-year-old daughter, E.I. On January 10, 2020 after Witness(1) understood that the two (2) nude photographs on Mussack's cell phone was her daughter E.I. she confronted him in the shower. Witness (1) advised when she confronted Mussack in the shower about the photographs, he kept yelling, "I'm so sorry I'm so sorry!" Witness(1) stated she told Mussack, "Its E.I.!" and Mussack admitted it was E.I. Witness(1) told Mussack to leave the residence and to go to work. Mussack left for work and Witness(1) contacted her friend who is a police officer. Witness(1)'s friend told her to respond to the Flagler Beach Police Department when she made contact with Detective Vinci.

Upon completion of this investigation it was determined by physical evidence and admission by Mussack, via a controlled call, that Mussack willfully and intentionally took photos of I.E.'s vaginal area for the purpose of sexual gratification.
