

OF THE CITY OF PALM COAST CODE OF ORDINANCES

#### Background:

The City Clerk and the Supervisor of Elections (SOE) have been negotiating the Interlocal Agreement for the 2020 Election season. For several years, residents have been requesting to have on-line campaigning finance reporting capabilities.

This year the SOE has proposed to allow the City's candidates use of the electronic campaign filing system. In order to allow City candidates to use the electronic campaign filing system through the SOE, the City must amend their code. Attached to this item, is a proposed amendment change to the Code of Ordinances to allow electronic campaign filing.

This change will allow the City Clerk and the public prompt access to campaign finance reports electronically filed with the SOE. Also, this change will allow for greater efficiency for the candidate as well as the City.

#### **Recommended Action:**

Adopt Ordinance 2019-XX Amending Article II, City Council, Section 37, to add a new subsection entitled "Electronic Campaign Filing," of the City of Palm Coast Code of Ordinances.

#### ORDINANCE 2019-

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PALM COAST, FLORIDA, AMENDING ARTICLE II, CITY COUNCIL, SECTION 37, TO ADD A NEW SUBSECTION ENTITLED "ELECTRONIC CAMPAIGN FILING," OF THE CITY OF PALM COAST CODE OF ORDINANCES; PROVIDING FOR SEVERABILITY, CODIFICATION, CONFLICTS AND EFFECTIVE DATE

**WHEREAS**, the City of Palm Coast is granted authority under Section 106.07(2)(a)2, Florida Statutes, to impose electronic filing requirements upon its own officers, candidates and political committees, not in conflict with Section 106.0705, Florida Statutes; and

**WHEREAS**, the City of Palm Coast recognizes that a requirement that all candidates for municipal office and all political committees file campaign finance reports electronically is not in conflict with the provisions of Section 106.0705, Florida Statutes; and

WHEREAS, all candidates for municipal office and political committees, as aforedescribed, shall utilize the Online Treasurer Reporting System maintained and operated by the Flagler County Supervisor of Elections Office; and

WHEREAS, the City Clerk, along with the public, hereafter will have prompt access to campaign finance reports electronically filed with the Flagler County Supervisor of Elections; and

WHEREAS, the Florida Legislature has significantly increased the frequency of filing campaign finance reports required under Section 106.07, Florida Statute, effective November 1, 2013, by now requiring monthly reports to be filed from the time the campaign treasurer is appointed, with additional reports due on the 25th, 11th, and 4th days prior to the election; and

**WHEREAS**, the City of Palm Coast finds and determines that uniform electronic filing of campaign finance reports by all municipal candidates and the aforedescribed political committees will facilitate expanded public access to campaign finance information and conserve City of Palm Coast resources leading to greater efficiency.

NOW THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF PALM COAST, FLORIDA, AS FOLLOWS:

**SECTION 1. AMENDING ARTICLE II, CITY COUNCIL.** The City Council of the City of Palm Coast hereby adds subsection (f) to Article II, City Council Section 37, as follows:

Sec. 2-37(f). Electronic campaign filing.

Ordinance 2019-\_\_\_\_ Page **1** of **2**  All candidates for elected office in the City of Palm Coast and all political committees filing with the Palm Coast filing officer shall electronically file their campaign treasurer's reports required by state law utilizing the Flagler County Supervisor of Elections Office's electronic filing system. Campaign treasurer's reports electronically filed as required by this section shall be deemed filed with the City Clerk simultaneously upon the Flagler County Supervisor of Elections office's receipt of the electronic filing.

**SECTION 3. SEVERABILITY.** If any section or portion of a section of this Ordinance proves to be invalid, unlawful or unconstitutional, it shall not be held to impair the validity, force or effect of any other section or part of this Ordinance.

**SECTION 4. CODIFICATION.** It is the intention of the City Council of the City of Palm Coast, Florida, and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinance of the City of Palm Coast, Florida; that the Sections of this Ordinance may be renumbered or re-lettered to accomplish such intention; that the word, "Ordinance" may be changed to "Section," "Article," or other appropriate word.

**SECTION 5. CONFLICTS.** All ordinances or parts of ordinances in conflict herewith be and the same are hereby revoked.

**SECTION 6. EFFECTIVE DATE.** This Ordinance shall become effective immediately upon its passage and adoption.

**WHEREAS**, the Assessment Roll has been filed with the City Manager or his designee, as required by law; and

- (A) The Tax Parcels described in the Nuisance Abatement Assessment Roll are hereby found to be specifically benefitted by the provision of the Nuisance Abatement services and programs in the amount of the Nuisance Abatement Assessment set forth in the Nuisance Abatement Assessment Roll.
- (B) For the Fiscal Year commencing October 1, 2019, the estimated Nuisance Abatement Assessed Cost for the Nuisance Abatement Service Area shall be calculated and apportioned based upon the actual cost of Nuisance Abatement. The costs as set forth in the Initial Assessment Resolution in Section 2.05 are hereby approved and found to be a fair and reasonable method of assessing the costs for the benefited properties.
- (C) The Nuisance Abatement Assessments as set forth in the Initial Assessment Resolution are hereby levied and imposed on all Tax Parcels described in the Nuisance Abatement Assessment Roll for the Fiscal Year commencing October 1, 2019.
- (D) Upon adoption of this Final Assessment Resolution, the Nuisance Abatement Assessments shall constitute a lien against the assessed properties equal in rank and dignity with the liens of all state, county, district or municipal taxes and other non-ad valorem assessments. Except as otherwise provided by law, such lien shall be superior in dignity to all other liens, titles, and claims until paid. The lien shall be deemed perfected upon adoption by the City Council of this Final Assessment Resolution and shall attach to the property included on the Assessment Roll as of the prior January 1, the lien date for ad valorem taxes.

#### SECTION 7. COLLECTION OF ASSESSMENTS.

- (A) The Nuisance Abatement Assessments shall be collected pursuant to the Uniform Assessment Collection Act.
- (B) Upon adoption of this Final Assessment Resolution, the City Manager or his/her designee shall cause the certification and delivery of the Assessment Roll to the

Resolution 2019-\_\_\_\_ Page 5 of 12 Tax Collector by September 15, in the manner prescribed by the Uniform Assessment Collection Act. The Assessment Roll, as delivered to the Tax Collector, shall be accompanied by a Certificate to Non-Ad Valorem Assessment Roll in substantially the form attached hereto as Appendix C.

SECTION 8. EFFECT OF FINAL RESOLUTION. The adoption of this Final Assessment Resolution shall be the final adjudication of the issues presented herein and in the Initial Assessment Resolution (including, but not limited to, the method by which the Assessments are computed, the Nuisance Abatement Assessment Roll, the terms for prepayment of the Assessments, the levy and lien of the Assessments, and the special benefit to assessed property) unless proper steps are initiated in a court of competent jurisdiction to secure relief within 20 days from the date of the City Council action on this Final Assessment Resolution.

**SECTION 9. SEVERABILITY.** The provisions of this Initial Assessment Resolution are severable; and if any section, subsection, sentence, clause or provision is held invalid by any court of competent jurisdiction, the remaining provisions of this Nuisance Abatement Initial Assessment Resolution shall not be affected thereby.

**SECTION 10. EFFECTIVE DATE.** This Resolution shall take effect immediately upon its adoption.

#### Background:

The Wastewater Pumping Division is seeking approval to replace the existing auxiliary generator located at Pump Station 33-2 located on Royal Palms Parkway which serves Rymfire Elementary School. The existing 2005 Detroit Diesel 60KW generator has been evaluated by two outside generator repair firms. It is in need of a complete stator rewind. Repair costs are estimated at \$28,500.00. This is more than half the cost of a replacement 60KW generator. The existing generator is 15 years old and replacement parts are difficult to obtain. Based on these considerations, it has been determined that it is not cost effective to repair the existing unit.

Tradewinds Power Corp is one of four approved generators in the Utility Standards and is the choice of staff based on prior history and performance. The cost to replace the generator also includes all electrical connections and startup. City staff will remove the existing unit and set the new generator in place.

City staff is recommending that City Council approve piggybacking the Florida Sheriffs Association Contract #FSA18-VEH 16.0 Specification #76 with Tradewinds Power Corp through September 30, 2019 for the purchase of a 60 KW Generator Package. Piggybacking existing competitively bid contracts is advantageous since the pricing is generally better than what the City could obtain on its own, and the City does not incur the expense and delay of soliciting a bid.

The Fiscal Year 2019 Budget includes available funding in the City's Utility operating budget to purchase a 60KW Generator Package. City staff estimates that the City will expend \$43,040.00 under this piggyback contract.
