Distler in reference to a closed court case# 2019 MM 000397. When Mr. McDonough was told he could not directly speak to her he became enraged slamming the door open as he exited the building while shouting obscenities. He got into a white Chevy Suburban and drove to the back of the building where he continued to yell at employee's while pointing his hand in a gun like manner saying he was going out with a bang. Mr. McDonough came back into the building stating he had a question and was told to leave by Deputy Cleo Howe. He was yelling in the parking lot so loud that the courthouse employees on the 2nd floor could here him. Mr. McDonough left three voice messages on Judge Distler's office phone stating she was unfair to him with the case. His voice and demeanor was escalting and he began screaming stating he is, "Sick of life and ready to take my own." Judge Perkins requested Mr. McDonough be trespassed from the courthouse and that his mental status be assessed by law enforcement. The Trespass warning was completed and turned over to Deputy Gib Smith.
