

Flagler County uses an optical scanner to read your ballot. You must completely fill in the oval in order for your vote to count. Any other mark may not be read by the scanner.

BEFORE

YOU GO TO VOTE:



- ★ Take your driver's license or another acceptable form of photo and signature identification with you (F.S. 101.043).
- ★ If you do not have acceptable photo and signature identification, you will be allowed to vote a provisional
- ★ If you have recently moved. please be sure that you change your address with the Elections Office BEFORE Election Day to avoid a delay at the polls.
- Check your voter information card for the precinct number and location of your polling place.
