~~At 6:45 Am 2/1/14 he bangs on my front door~~  
At 1:00 Am 2/1/14 I hear some one trying to  
enter my patio door. I look out see no one  
& try to go back to sleep. Then I receive  
his blank text at 4:19 Am. (Just to wake me I'm sure)  
At 6:45 am 2/1/14 He bangs on my front door &  
rings the doorbell over & over. I look out my window

After talking to me he decided to go to Mr. NeJames

Told her what had happened, she read the emails & texts. Here is what she said "He is a control freak, but what I am concerned about is he is obsessed with you & it could become violent." Since I live alone this worries me very much.

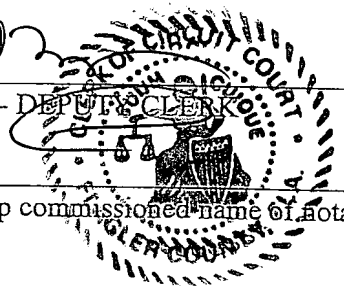
