When several of the subjects observed law enforcement approaching they quickly entered a residence, and then exited through the backdoor. When law enforcement walked around the back of the building, we observed the subjects entering a vehicle, and leaving the scene. FCSO conducted a traffic stop on the vehicle, and the occupants could not provide a legitimate reason for being on the property. The occupants, who are identified as Christian A Melendez (DOB 06/29/99), Edwin Melendez (DOB 07/06/95), and Keith Antieny Colby Bryant (DOB 12/13/98) were subsequently trespassed from the property. -Ofc Roberts
