MOTION FOR CONTEMPT

Plaintiff, Department of Legal Affairs (herein "Department"), by and through the undersigned attorney, files this Motion for Contempt pursuant to Rule 1.560, Florida Rules of Civil Procedure and in support thereof states as follows:

1. On March 16, 2020, the court entered a Final Judgment in the above-styled cause against Defendant Dennis McDonald in the amount of \$79,564.05 plus interest at the legal rate of 6.83% per year. This judgment has not been satisfied.

2. The Final Judgment ordered Defendant to complete, under oath, Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet including the spouse related portion) including all required attachments and serve it on counsel for the Plaintiff within 45-days from the date of the Final Judgment.

3. The 45-day period has lapsed and Defendant has not served the Fact Information Sheet on Plaintiff's counsel.

4. Defendant has the present ability to complete and return the Fact Information Sheet and has had more than enough time since the date of the Final Judgment to comply.

5. In an effort to resolve this issue without judicial intervention, the undersigned contacted Defendant through a correspondence dated September 16, 2020 and requested that he

6. Good cause exists to hold Defendant in contempt for failure to comply with this court's order.
