as a family unit. [REDACTED] and Michael have been engaged for five months and together for a total of six months. They have no children in common.

On the previous day, [REDACTED] (positively identified by her Florida Driver's License) advised the following in a written statement:

"Around 5am this morning Michael woke me up to have sex. About 20 min. after that he came back in our room, laid next to me and started asking questions about me talking to other guys. He said he knew everything, that I'm a whore and he called some guys to "come take care of me". He told me to come out on to the couch and sit down. He sat across from me with 2 guns and told me not to move. I asked "what are you going to shoot me if I run?" He said if he had to. This went on for probably 2 hours, him telling me "don't fucking move". He started threatening my animals and tried to forcibly take my small dog from me several times. He left the room at one point, I ran towards the front door. But I saw him coming back so I grabbed the purple knife off the counter. I ran to the opposite side of the room. He said "drop the knife", I said put the gun down". He then slightly raised the gun and asked me to drop the knife again. I dropped it. This whole time he held my phone, keys, and wallet hidden. He backed off a little so I went back in the bedroom. He followed me, telling me he wouldn't hurt me, blah, blah, blah. I went back out to the living room and tried to go out the back door but he stopped me. At that point I screamed "help" as loud as I could. He came over, grabbed me, put his hand over my mouth and nose and drug me back in the bedroom and threw me down on the bed. I started talking about calling the cops and he seemed to get panicky. He said if I stayed calm he would give me my phone and stuff back. Over about the next hour he one by one gave my things back. Then he spent a while begging me not to call or tell anyone what happened. I asked him to go for a drive and give me time to calm down and feel safe again. He agreed. After he left I called the non-emergency number to file a report."

Contact was made with Michael Adams (positively identified by her Florida Driver's License), who wrote the following in a sworn written statement:

"Over the last several days, [REDACTED] has been extremely emotional about her divorce saying that I ruined her life. She has spent moments crying hysterical saying she doesn't want this life any more. Early morning she started being extremely emotional saying her life is over and an argument ensued. She then proceeded to follow me into the kitchen and grab a knife. We began to argue and it was back and forth throughout the house going nonstop. It started to escalate, so I proceeded to gather my firearm and leave the house. She also scratched and cut me on the head and arms. It was a purple kitchen knife that she had grabbed, I was struck on the head

with the knife and I'm not sure if it was her nails or the blade on my arms."

Upon further review of the details, body camera footage, and initial statements from both parties, the Flagler County Sheriff's Office Investigative Services Division determined Michael to be the primary aggressor in the incident. It should be noted that Detective St. John advised that Michael was at the residence and that he had been texting and calling [REDACTED] requesting she not pursue criminal charges against him. It should be noted that according to Detective St. John, [REDACTED] was in fear of returning to her residence with Michael there. It was previously known that Michael had an unknown amount of firearms in the residence in multiple places, including his vehicle.

Deputy Schmidt and I arrived on scene and stood by for other units to arrive on scene prior to contact with Michael, given the allegations and knowledge of firearms in the residence. While standing by, I observed [REDACTED] pass by our location and pull into the driveway. I observed her get out of the vehicle and walk into the house at the same time Michael exited the residence. Deputy Schmidt and I closed in on the house, but not quickly enough to prevent [REDACTED] from going inside. Once Michael observed Deputy Schmidt and I approach his residence, he retreated back into the residence as [REDACTED] exited and was taken to a safe location. Michael was advised he was being placed under arrest and to come to deputies. Michael, knowing he was being placed under arrest, opened and closed the door multiple times, all while refusing to come out. Michael called in to the Flagler County Sheriff's Office Communications Center where he advised he would not come out until he could speak with a deputy about the reason for law enforcement presence at his residence. Michael was advised of such and agreed to come out after 10 minutes or so. Michael exited the residence and cooperated with law enforcement commands. Michael immediately advised he refuses to speak with law enforcement and wished to speak with an attorney.

The purple knife was retrieved from the residence as evidence, as well as Michael's phone, due to Detective St. John advising she has knowledge of Michael texting and calling [REDACTED] requesting she not file charges. A handwritten letter was located on the kitchen counter that read "[REDACTED] please do not file charges". The letter was also taken for evidence. All items listed above for evidence will be submitted by Deputy Schmidt. [REDACTED] advised she could not identify which firearms were used by Michael when he was sitting on the couch. Detective St. John advised to leave all firearms in place as she would attempt to obtain a search warrant to obtain the firearms for purposes of the investigation.

Michael was placed under arrest and charged with Domestic Battery, Domestic Aggravated Assault, False
