HISTORICAL PERSPECTIVE

1539 – Introduced by Hernando De Soto

Population estimates in Florida are >500,000, which could be a great underestimate. -Florida Fish and Wildlife Commission (FWC)

No Known County-level population estimates

No known County Land population estimates*


Females tend to live a little longer past age 3

Gestation period is 4 months






+/- 9 million hogs in 35 states



2016 USDA: almost 6 Million in crop loss in Florida Alone, \$190 Million Regionally




ECONOMIC PERSPECTIVE-FLORIDA



Local Residents living in HOA neighborhoods have reported needing to spend thousands of dollars on repeated impacts from hogs in recent years.

Some HOAs don't allow individual fencing or have other restrictions on managing hogs.



WHAT DO WE DO ON COUNTY LANDS?

We've had volunteer feral hog management agents on County conservation lands for decades.

Generally, these volunteers are hunters/trappers.

Current Requirements:

- -Licensed through county internal processes
- -carry \$1,000,000.00 insurance
- -County is included as additional insured
- -Monthly Reporting

Averaged 100-150 hogs per year......

WHAT DO WE DO ON COUNTY LANDS?

Corral Traps:

Ability to trap dozens at a time

Net vs Metal trap is more humane for the animal

No loud metal caging or doors to create trap shy pigs

A gateless trap provides continuous catch ability throughout the night

Acts on there natural instinct to root for food to gain access to trap

Interrupt the population dynamics more quickly

Reduce time and effort of staff and volunteers



WHY SUCH A JUMP IN NUMBERS?

Corral Traps:

Capture large numbers when effective

Interrupt the population dynamics more quickly

Reduce time and effort of staff and volunteers





WHAT'S NEXT?

We are working on developing a tech-based way to collect population data on County lands.

Thermal Imagery with Drones

Increase efficiency in hunting/trapping effectiveness

If the method works we'll be able to establish a baseline population estimate within parks to measure against in the future.

Work is being done in-house with our UAV coordinator Bruno Luna



WHAT DO WE DO ON PRIVATE LANDS?


We can not apply resources on private property.

Hog Panel Fencing

Electric Fencing

Trap/Hunt - Hogs can be trapped or hunted yearround with the only limitation being landowner permission or municipal ordinance
