#### FL Education Budget (continued)

- Loss of Students to various school choice options will make this budget extremely challenging
- ☐ Average District loses 1% of students with only 1.59% more on average in per UFTE funding
- Funding Vouchers "Above the Line" Hides this Reality from the Public and Requires Access to Multiple Documents to Understand What is Happening to the Various Districts
- No Increases to Safe Schools or the Student Mental Health Allocation for the First Time Since MSD High School Tragedy (even with FSU Tragedy)
- □ New Policy on Add-On Weights for Acceleration and CTE Successful Test Scores (SB 2510)
- ☐ FRS Costs Increase for School Districts Statewide by nearly \$80 million statewide

#### Flagler Schools Local Budget Impact

- Legislature Provides 1.59% increase per student on Average Statewide with Flagler Schools getting a 2.36% increase per UFTE
- Legislature Provides about \$1.9 Million increase to the District's Total Potential Funding, but then Requires the District to Spend about \$2.2 Million more next year on Legislative Requirements, leaving a small deficit as Legislative Policy
- Other local commitments for next year, including health insurance increases and planned raises would require another \$3.5 million that Flagler Schools does not have in this state budget

# SB 2510 – Education Conforming Bill to the Budget



- Schools of Hope
  - Funding
  - Co-location
  - Definitions of Persistently Low Performing School
  - Inclusion of Flager Request Regarding U-PreK Student Counting Toward Capacity per this Program
- Acceleration and CTE Program Funding
  - ☐ Shifted to Allocation from Add-On-Weights
  - Changes to Middle School Digital Tool Certificates
  - DOE Lists Allowable (for funding) CAPE Programs by Grade
  - New Spending Limitation to Not Cover "Base Costs of Program"
- DOE Submits FEFP Calculations to Legislature and Governor without a Conference with No Duplication of Students
- DOE to Recommend a Title I School Performance Incentive Program no Later than July 1, 2028
- Other Conforming Bill with Safeguards for Vouchers Failed in Conference Negotiations (See SB 7030)
