Case Narrative

On June 28, 2023, at approximately 1900 hours, I, Deputy Barrett was dispatched to Palm Coast Community Center, 305 Palm Coast Parkway NE, Palm Coast, in reference to property damage.

Upon arrival, I spoke with the president of "Community Cats of Palm Coast" (CCOPC) Jessica Myers (W/F, 06/18/1971), she stated that one of her feeders for her cats had been damaged. She explained that the feeder was placed in the woods off the walkway between Linear Park and Club House Drive. Jessica stated that one of her workers last saw the feeder not disturbed around 1500 hours this afternoon. Jessica stated that she then checked on it at 1700 hours to feed the cats and saw that it was destroyed. Jessica explained that the feeder had been placed there for over 10 years and she does not know anyone who would damage it.

I observed the feeder destroyed and a clay pot broken. The damaged property was placed in the nearby trashcan on the walkway. Jessica explained that she did not wish to pursue charges in the matter she just wanted it documented.

I provided a case card to Jessica, and she provided me with photos of the damaged feeder. Photos will be uploaded to AGEIS/LERMS in a timely manner.

The incident was recorded on my AXON body-worn camera.
