## ORDER GRANTING MOTION BY THE FLAGLER COUNTY BOARD OF COUNTY COMMISSIONERS TO APPROVE SETTLEMENT AGREEMENT WITH DEBTOR

THIS CASE is before the Court upon the Motion (the "Motion") by the FLAGLER COUNTY BOARD OF COUNTY COMMISSIONERS ("Movant" or "Flagler County BOCC") TO APPROVE SETTLEMENT AGREEMENT WITH THE DEBTOR, CYNTHIA A. D'ANGIOLINI ("Debtor") (Doc 48). The record reflects that no interested party filed an objection or other response to the Motion within the time contemplated by Local Bankruptcy Rule 2002-4. Accordingly, the Motion is hereby deemed unopposed. Having reviewed the Motion, the file and otherwise having been advised on the premises, it is

## **ORDERED**:

1. The Motion is granted.

- 2. The Settlement described in the Motion is approved, is fully enforceable in all respects and is incorporated herein. The Debtor and the Movant shall comply with all of the terms of the Settlement.
- 3. The Easement Documents described in the Motion and executed by the Debtor, shall be released from escrow and delivered to the Flagler County BOCC. The Easement Documents may be recorded into the public record and used by the Flagler County BOCC in all manners consistent with the stated purpose outlined in the Motion.
- 4. The Chapter 13 Trustee is hereby authorized to disburse the \$4840 previously paid to the Chapter 13 Trustee by the Debtor, which shall be paid out *pro rata* to unsecured creditors of the Debtor in amounts determined appropriate by the Chapter 13 Trustee.
  - 5. The Flagler County BOCC shall file the following documents:
- (a) Notice of Withdrawal of the Flagler County BOCC's Motion to Vacate Discharge and Convert Case to Chapter 7 (Doc 28);
- (b) Notice of Withdrawal of the Flagler County BOCC's Objection to Debtor's Motion to Modify Confirmed Plan (Doc 33); and
- (c) Notice of Voluntary Dismissal of Adv. Pro. No. 22-ap-00096-LVV, styled: The Flagler County Board of County Commissioners vs. Cynthia A. D'Angiolini.
- 6. This Court shall retain jurisdiction to enforce the terms of this Order and to enforce the terms of the Settlement, as may be appropriate.
