On May 17, 2015 at 9:42AM I, Deputy Jurec responded to 5853 Apricot Ave Bunnell Florida in reference to an notification welfare check being called in by, Aaron Thayer, from Connecticut on his father, George Contos.

Upon my arrival no contact was made at the residence and no vehicles were located in the driveway. After speaking with Aaron via PX he advised us to make entry into the residence and garage to look for his father because he had not spoken to him in a few days.

Myself and Deputy Hart were able to make entry through an unlocked front window into the residence but were met with negative results for George. Entry was then made through the side garage door with help with the Flagler County Fire department where nothing appeared out of place or unusual. The garage was then secured and contact was made with Aaron who advised his father was supposed to leave for a friend's House in South Carolina but had not arrived yet.

Local Hospitals were contacted but had no patients matching that were admitted or released. A check for accidents involving a 1997 white in color Lincoln Town Car bearing Florida tag N54-6YQ also came back with negative results. When Aaron was asked if his dad would hurt himself or had any medical conditions he advised that George would not hurt himself and that the only medical condition he had besides missing his left leg was that he was diabetic. At that time Aaron stated he would be on his way to Florida and would contact us when he arrived.

On May 20, 2015 at 3:04PM I, Deputy Jurec, made contact at the above address with, Aaron Thayer, who still had not heard from his father. I then Completed a Florida Department of Law Enforcement Missing or endangered person report form which was turned into Dispatch to add, George Contos, to FCIC/NCIC as missing. Detective Kuleski of the Investigative service Department arrived at this location and the case was turned over to him at that time. I have no further information to add to this report at this time.
