Upon conversation with Jeffrey, I requested his ID, which he declined. I proceeded to address the harassment allegations which he denied and stated "Have you seen me harass anybody."

At this point, he is not detained and is free to leave; he refused.

I made contact with the Funky Pelican management and an employee to continue my investigation of trespass. Management advised that Jeffrey was harassing people coming in and out of the restaurant and also taking pictures of people. They advised that he was resistant to their request to stop harassing the customers, and he refused to leave upon their request.

Funky Pelican management wished to have Jeffrey trespassed.


I returned to Jeffrey, who was standing in front of The Funky Pelican on the City of Flagler Beach Boardwalk area. I informed Jeffrey that The Funky Pelican wished to have him trespassed. At that point, I verbally trespassed him from The Funky Pelican and requested that he simply move down the sidewalk one way or another, to which Jefferey once again refused.

Sergeant Yelvington arrived on the scene a few moments later and advised Jeffrey of the trespass yet again, this time for The Funky Pelican and the City of Flagler Beach Boardwalk area and Pier.

Jeffrey once again stated that he would not identify himself, he would not answer questions, and he would not leave.

Jeffrey was warned numerous times verbally about being trespassed and continued to refuse. Subsequently, Jeffrey was arrested for trespass after warning.

Upon incident to arrest, a search of his person was conducted, a Smith and Wesson

Bodyguard 2.0 .380 caliber pistol was recovered from his right front pocket.

It should be noted that the firearm was loaded with one in the chamber.

Jeffrey was placed in the back of my agency-issued marked patrol car with some assistance as he claimed he could not get into the vehicle.

Jeffrey was transported to Flagler County Inmate Facility without incident.

A trespass warning was completed on Tracs, and Jeffrey was issued a copy for his records.

The Smith and Wesson firearm will be submitted into evidence at FBPD.

Jeffrey was charged with "trespass armed with firearm" for possessing the Smith and Wesson on his person while trespassing after warning.

It should be noted that Jeffrey also had cameras set up. Those were collected per Jeffrey's request and will be submitted for safe keeping at the FBPD.

Nothing further at this time; body-worn camera AXON 3 was utilized.
