several family members went out to dinner. [redacted] stated once they arrived back at their residence Tina began yelling at everyone because Tina could not find her keys. [redacted] stated her younger sister, [redacted] became upset and [redacted] told Tina to stop yelling.

[redacted] stated Tina began yelling at her, telling [redacted] that she is a problem and Tina doesn't love her anymore. According to [redacted] Tina stated [redacted] had to leave and was not allowed to return. [redacted] stated at this time she called her father, Ryan Tietjen, to come pick her up. [redacted] stated [redacted] and [redacted] (brother), also wanted to go to their father's house, because of Tina's behavior. [redacted] stated this infuriated Tina and she began yelling at [redacted] stated she stood in the doorway of [redacted]'s bedroom to separate Tina from [redacted]. [redacted] stated Tina grabbed her and physically removed her from the doorway.

[redacted] stated Tina began to advance towards her again in an aggressive manner. [redacted] stated she was in fear of Tina and grabbed a knife from the kitchen counter. [redacted] stated she never threatened Tina with the knife, but told her to stay away from her. [redacted] stated her uncle, Michael Boswell (Witness), took the knife out of her hand and separated [redacted] and Tina.

[redacted] stated she poured out Tina's beer out of anger, because Tina is an alcoholic. [redacted] stated Tina attempted to drive to the store to get more beer, but she hid the car keys from Tina. [redacted] stated Tina began yelling at her again. [redacted] stated Tina placed both of her hand forcefully around her throat and restricted her breathing. [redacted] stated Tammy stepped in and separated them. It should be noted [redacted] had visible red marks around her throat. [redacted] declined medical attention and refused photographs.

At this time I made contact with Tammy who stated the following:

Tammy stated Tina was extremely intoxicated and argumentative. Tammy stated she observed Tina forcefully place her hands around [redacted]'s throat. Tammy stated Tina would not stop and Tammy had to physically separate them. Tammy stated she did not witness [redacted] with a knife in her hand. Tammy completed a sworn written statement.

At this time I made contact with Michael Boswell, who stated the following:

Michael stated he also observed Tina forcefully place her hands around [redacted]'s throat. Michael stated he observed [redacted] with a knife in her hand, but [redacted] did not make any threats toward anyone. Michael also stated he immediately took the knife out of [redacted]'s hand and separated [redacted] and Tina. Michael provided a sworn

At this time I attempted to make contact with Tina, but she would not answer the door. The residence was locked and I was not able to observe Tina inside the home through multiple windows. Multiple family members on scene stated Tina was so intoxicated she is most likely asleep.

At this time Tina is charged with Child abuse for knowingly and willing causing harm to a child. A search in CCIS revealed Tina has no prior domestic violence charges. Deputies will attempt to locate Tina and take her into custody. If Tina is not located in a reasonable amount of time, a charging Affidavit will be sent to the State Attorney's Office for further review.

Ryan Tietjen (father) arrived on scene at this time. Ryan took the children to his home located at 16 Lansdowne Ln. I provided domestic violence paperwork to Ryan and [REDACTED]

The Department of Children and Families was notified via the online reporting system. Axon video available. I have nothing further to report at this time.
