The right front passenger, now known to be Adrian A Gillihan (G450-001-70-307-0) had an active Felony Warrant for VOP in reference to possession of methamphetamine with intent to sell and use of a 2-way communication device to commit a felony. Mr. Gillihan had an additional active warrant for violation of probation in reference to possession of a schedule IV substance with intent to sell within 1000FT of a school. Lastly the back seat passenger, now known to be Nichole M Beard (B630-633-80-881-0), possessed a valid Florida Driver's License with no active wants or warrants.

Once Mr. Gillihan was asked to exit the vehicle, Deputy Gonzales observed a used hypodermic needle on the floorboard next to his person. Due to Mr. Gillihan being unable to provide a reason why the needle was uncapped and in its position and previous narcotic related arrests, a search of the vehicle was conducted to verify there wasn't any other narcotic related contraband in the vehicle.


Mr. Rando was asked to exit the vehicle and search of Mr. Rando was conducted. Mr. Rando had multiple denominations of US Currency in his left front pocket, a pen cap, as well a cap to a hypodermic needle. Sergeant Weaver advised me that while he conducted the search of the vehicle, he located a used uncapped hypodermic needle in the pull out cup holder directly below a small black "vape" liquid container. Mr. Rando stated that the black "vape" liquid container was his. There was also a black in color fixed blade knife concealed below a tray in the center console area. Let it be known that the sheath for the knife was not located within the vehicle during the search. It should also be known that even though the State of Florida was currently declared in a state of emergency, the vehicle was driving around the evacuation zone and was not actively evacuating.

Within a pocket inside Mrs. Beard's purse, a used hypodermic needle along with a "loaded" hypodermic needle. Inside the "loaded" hypodermic needle was a brown substance that is consistent with methamphetamine. See Sergeant Weaver's supplement for further information.

Mr. Rando advised that the hypodermic needles that were located in Mrs. Beard's purse had belonged to Mr. Gillihan who was previously sitting in the back seat. Mr. Rando also advised me that the contents of the hypodermic needle is methamphetamine.

All items will be submitted into evidence, excluding the hypodermic needles pictures will be taken and uploaded into Aegis, and Taser Axon will be uploaded in a timely manner.
