(1) HOW VIOLATION OCCURRED: Violation of Condition (2) of the Order of Probation, by failing to pay the State of Florida the amount of \$10.00 per month toward cost of supervision, plus a 4% surcharge, unless otherwise exempted, in accordance with Section 948.09, Florida Statutes, and as grounds for belief that the offender violated his Probation, Officer Coleman states that the offender is \$ 360.00 in arrears, as of 07/01/2021.

Violation of Condition (10) of the Order of Probation, by failing to make court cost payments to the Clerk Of Court as directed in accordance with the payment instructions of the court, and as grounds for belief that the offender violated his Probation, Officer Coleman states the offender is \$1275.96 in arrears, as of 07/01/2021.

Circumstances: The subject has not made any payments toward his monetary obligations. He stated he should have been paying all along to avoid this situation. He has been working steadily at Everglades Boat Manufacture in Edgewater, Florida since April 2021.

(2) OFFENDER'S STATEMENT: The Offender did not have much to say about owing the money. He stated he should have been paying it. He understood a Violation was needed to let the court know the situation.

(3) HISTORY OF SUPERVISION: ADJUDICATION WITHHELD ADJUDICATED
Original sentence: On 08/01/2018 the subject was sentenced to 180 days county jail followed by three years of Drug Offender Probation, for committing the offense of Ct I: Possession of Cocaine and Ct II: Tampering with Physical Evidence. Special conditions imposed include: to complete a Substance abuse evaluation and any recommended treatment, to abstain from alcohol and illegal drugs, submit to urinalysis on a monthly basis and ordered not to entire any establishment where the primary business is the sales of alcohol.
