and repeatedly tried to give her the non-emergency phone number, but Eyrich seemed resistant or unwilling to utilize the non-emergency number.

The audio from the six 911 calls have been uploaded to AEGIS. These calls have not been redacted.

In addition, Eyrich was believed to have consumed an unknown amount of alcohol and was in possession of an alcoholic beverage. Eyrich is on probation for Misuse of 911 and a condition of her probation is no alcohol consumption.
