- I) LEWD/LASCIVIOUS MOLEST PRSN 18 YOA/OLDER VIC.<12 YOA
- II) FAILURE OF SEXUAL PREDATOR TO PROPERLY REGISTER
- III) POSSESSION OF CANNABIS NOT MORE THAN 20 GRAMS

R.J. LARIZZA, State Attorney for the Seventh Judicial Circuit of the State of Florida and as such prosecuting attorney for this Court, in the name of and by the authority of the State of Florida charges that:

COUNT I: MESHAC MOLETTE ABENTEGO on or about July 17, 2014, in the County of VOLUSIA and State of Florida. MESHAC MOLETTE ABENTEGO, a person 18 years of age or older, did unlawfully and intentionally touch , a person less than 12 years of age, in a lewd and lascivious manner the breast, genitals, genital area, or buttocks, or the clothing covering them, contrary to Florida Statute 800.04(5)(b). (LIFE FEL)

COUNT II: IN THAT MESHAC MOLETTE ABENTEGO on or about July 17, 2014, in the County of VOLUSIA and State of Florida, MESHAC MOLETTE ABENTEGO, being a sexual predator, did not comply with the requirement of Florida Statutes 775.21 in that he unlawfully failed to register, or after registering, did fail to renew his driver's license or identification card or provide the required address and/or location information, contrary to Florida Statute 775.21(10)(a). (3 DEG FEL)

COUNT III: IN THAT MESHAC MOLETTE ABENTEGO, on or about July 17, 2014, in the County of VOLUSIA and State of Florida, was unlawfully and knowingly in actual or constructive possession not more than 20 grams of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13(6)(b). (1 DEG MISD)

1 Unlawfully and intentionally use his hands to touch the victim's buttocks area in a lewd and lascivious way knowing that the victim was less than 12 yrs old.

4 One today's date, I was dispatched to on St. in reference to a sexual battery. Upon my arrival I made contact with the RP (mother). The RP stated she was asleep this morning when her daughter (V-1) came in and stated that last night "Meshac came in my room and was touching me".

7 The RP stated defendant is a family friend and had been helping her move into her new home the last two days. The RP advised that her daughter (V-1) stated that she awoke to the defendant touching her butt area and then he ran out of the house.

10 I made contact with Detective Deschamps and she made arrangements for a forensics interview to be completed with the Children's Protection Team. The RP and victim were transported to the police station for this interview with CPT member Rebecca.

13 During this interview the victim disclosed that she was sleeping in her bed and awoke to the defendant touching her butt all over. The victim advised that she was lying down and the defendant was standing over her with his hands inside her pajamas. Once asked how she knew his hands were inside she stated "I felt it, I thought it was a cockroach", "I woke up and saw him". The victim advised that the defendant had on a red hat, white t-shirt


