C. Presentation

C.1. Fiscal Year 2023/2024 General Fund Tentative Budget Discussions

Finance Director Moss went through a presentation regarding the General Fund. Included in the presentation was information on how to read the property tax bills and a comparison of some tax bills showing the proposed .1/2 mil increase and how much a tax bill would increase just on the increased assessed property values and with the 1/2 mil increase to the Bunnell rate.

Commissioner Young asked if any funds would be left over from this year. Finance Director Moss stated we would not know if there will be any carry over budget until the end of August or September.

Mayor Robinson asked if there were grants to assist cities becoming ADA compliant. City Clerk Bates stated the City continually looks for these, but most authorities feel it is the responsibly of the local government. City Manager Jackson also confirmed this is now one of those unfunded mandates on government and is something to be addressed to receive grants like CDBG.

Vice Mayor Rogers noted if the City did not increase the millage, it would not be able to function and level of services could be affected. He stated when the City sees a 26% increase in the insurance with no claims it is difficult to operate without an increase.

Commissioner Schultz stated she went through the budget with a fine-toothed comb and praised staff for their hard work on the budget because she knows it was hard to prepare something operating at the basics. Commissioner Schultz stated she was the last person to want to increase taxes, but also does not want the level of service to be cut either.

Commissioner Young reminded everyone the City needs to have funds available for emergencies.

Mayor Robinson said the .5 mil increase doesn't cover the rise in costs the City has no control over such as insurance costs, FRS and the salaries to the Police Department. This budget is all about safety and continuing services. She stated there is not much the City can do when faced with unfunded mandates.

Public Comments

Richard Scott (Fairway Court) stated he appreciated the Board reducing the proposed millage rate from 1 to .5 increase. He said after seeing the presentation he understands why the City is between a rock and a hard place and noted the Police Department was the largest expense to the City. He stated the Police Department does a great job but suggested they become more aggressive handing out citations which might create some revenue to cover their operations. He stated the public may be interested in helping with recreational needs or there might be some corporate donations to make changes to the parks. He understands the City does not have anywhere to make more cuts in the budget and appreciates all the efforts of the City to keep costs down as much as possible.

Mayor Robinson stated there are numerous properties that do not pay taxes such as churches and government properties within the City limits or even though whose exemptions exceed the assessed value of their home. She stated many citizens did not fully understand their tax bills, especially when it comes to CDDs and the exemptions they get through portability or homestead, etc. which further reduce the taxes collected for use to provide services to the citizens.

Mayor Robinson recognized the staff for the hard work they did to balance the budget and to be sure to cover essential items while addressing rising costs too.

City of Bunnell 2023/24 Budget – Millage rate increase

Unfortunately, I have not been able to attend the Commission meetings regarding the budget and am also unable to attend the budget meeting tonight, but I have read the minutes of the meetings. As a result, I have decided to email you expressing my disappointment with the decision to raise the millage rate for COB. At the July 24th meeting I understand the max millage rate of 8.43 mil was approved and at a subsequent meeting it was reduced to ½ mil to 7.93.

I would like to reiterate Mr Scott's comments: -

With property values increasing and more houses being built in Grand Reserve, the City should be getting the revenue it needs to operate with little to **no** millage increase. He advised Palm Coast actually rolled back their rate and while they may be a bigger jurisdiction, they still did it. He stated Bunnell needs to learn to live on its existing revenue. The residents in Grand Reserve pay a lot of money to live there. He feels raising taxes will hinder growth and stop people moving to the City.

As Mr Scott has said Palm Coast's proposed MR is 4.61 and I understand it generates more revenue, but Flagler Beach's proposed MR is 5.45, a city that has very little business. COB is proposing an increase in the millage rate when the services are not of the quality of PC or FB and we have seen no improvement to the infrastructure with previous increases. Also, it seems there is a proposal to increase the waste disposal rate. Why not look at reducing the service (if it far exceeds other surrounding city's service) and maintain the rate, although I agree the rate has not increased in 5 years of living here. I would support this increase if there was no increase in the millage rate! New City Halls and Police Stations and Libraries are being built before replacing aging infrastructure. When the water treatment is as poor as it is (as well as other services) to the point everyone in Grand Reserve has their own whole house water softener and filtration system, this doesn't look great to new residents who are simply going to move to neighboring cities, rather than suffer increasing costs for no return.

Grand Reserve is one of the main sources of tax revenue for COB and as a Deer Run CDD board member, I understand budgets and the need to work within them. Grand Reserve is a developing community and is facing 20-28% increases annually largely due to no support from COB and DR Horton with regard to old aging infrastructure. We have a new development that has old crumbling roads, and a defunct irrigation system and residents are left to pick up the pieces financially. This is wrong!

So, you are expecting your largest tax contingency to absorb CDD increases, COB tax increases, waste service increase while neighboring cities' costs are much lower. Most Grand Reserve residents are disgruntled and once the economy improves, many will move should this situation continue, including myself!

In 2017 the City entered into an ILA with the Flagler County Board of County Commissioners for 911 Addressing.

This agreement is in need of amending as some of the language is outdated. There are no substantive changes to the responsibilities already being carried out by the City or the County.

**AMENDED AND RESTATED INTERLOCAL AGREEMENT BETWEEN
THE CITY OF BUNNELL AND THE FLAGLER COUNTY BOARD OF COUNTY
COMMISSIONERS FOR ENHANCED 911 ADDRESSING**

THIS AMENDED AND RESTATED INTERLOCAL AGREEMENT (“Agreement”) is made and entered by and between the City of Bunnell, Florida, a Florida municipal corporation (hereinafter “City”), and Flagler County, Florida, a political subdivision of the State of Florida (hereinafter “County”), collectively referred to as the “parties”. This Agreement replaces the prior agreement entered into by the parties and recorded at book 2196 and page 1823, on April 4, 2017.

WITNESSETH:

WHEREAS, pursuant to Section 163.01, Florida Statutes, local governmental units may enter into interlocal agreements to cooperatively and efficiently use their powers to provide public services that will advance the general health, safety and welfare of the citizens of Flagler County; and

WHEREAS, the County maintains the Enhanced 911 (E911) system and the 911 Automatic Location Identification (ALI) Database on behalf of both the incorporated and unincorporated areas of Flagler County; and

WHEREAS, the County’s E911 Coordinator, pursuant to Section 365.171(4), Florida Statutes, and Chapter 60FF, Florida Administrative Code, oversees and coordinates the official addressing and street naming duties of the unincorporated and incorporated areas of the County; and

WHEREAS, the parties hereto recognize and agree that it is desirable to enter into this Agreement for the mutual benefit of each party in enhancing the delivery of emergency services; and

WHEREAS, this Agreement is for the benefit of the general public so that the possibility of delay in the delivery of emergency services due to incorrect, duplicate or incomplete addresses can be reduced.

NOW THEREFORE, the parties hereto agree to assist the other party pursuant to the following provisions:

Section 1. Purpose and Intent of Agreement

To better serve the citizens of Flagler County and reduce the possibility of a delay in the delivery of emergency services due to a lack of uniformity in addressing, the City and County agree there is a need to establish a single authority in the assignment of addresses and street names within their jurisdictions. The E911 Coordinator already maintains addressing information for unincorporated Flagler County, the parties agree that the E911 Coordinator be the single authority for assigning addresses and street names within the parties’ jurisdictions.

Section 2. Duties

- (A) The E911 Coordinator will coordinate and oversee all tasks related to updating the E911 ALI Database, the Master Street Address Guide, and all other necessary tasks required to maintain E911 emergency location system integrity.

(B) The County and the City will distribute notices to all affected residents within the City's jurisdiction concerning any changed addresses with instructions to post and begin using the new addresses, in accordance with Flagler County Code Chapter 24, Article II, and City of Bunnell Code Chapter 18, Article III.

(C) Flagler County will provide the following addressing support at no cost to the City:

1. Process all addressing requests, concerns, questions, and inquiries from the City's residents when possible and refer them to the City when additional research or information may be needed.
2. Ongoing addressing review and approval or denial of street naming for new development(s).
3. Ongoing maintenance of mapping and addressing files.
4. The County, pursuant to Flagler County Code Chapter 24, Article II, will provide necessary notification letters to E911 address requestors conforming or denying the issuance of an E911 address with notification to the City's addressing database manager.

(D) The City hereby agrees to submit to the E911 Coordinator the following information and documentation in support of the ongoing tasks noted in Paragraph (C) above:

1. One (1) copy of each of the City's municipal ordinance(s) involving annexation and de-annexation of property within ten (10) business days after final adoption.
2. One (1) copy of all proposed or preliminary plats, in electronic format when available, for the purpose of approving or denying official roadway names thereon within ten (10) business days of receipt.
3. One (1) copy of all final, approved plats, in electronic format when available, for the purpose of affixing official addresses thereon within ten (10) business days of final approval. (Note – most of the City is platted, new residences typically arise by building permits within antiquated subdivisions and through properties sold by metes and bounds and then developed.)
4. One (1) copy of any official roadway closing/vacation of City right-of-way and/or alleys or extensions within ten (10) business days after final approval.

(E) The E911 Coordinator will work in cooperation with the City and any concerned subcontracts, as well as with the County Property Appraiser, County Public Works, and any other necessary offices or agencies in implementing and maintaining the addressing system.

- (F) The City and County hereby agree that address changes, including changes to the house numbers and to the street, as well as the initial street naming process will first be routed to and coordinated through the City as a central point of contact for properties within the City's jurisdiction.
- (G) The City will work in cooperation with the County for all address assignments and changes as well as all street assignments and changes to ensure that no duplicate or incorrect address becomes a part of the Uniform 911 Addressing System.
- (H) The City and County hereby agree to mutually cooperate in maintaining the flow of communication necessary to properly and effectively institute the Uniform 911 Addressing System as implemented in unincorporated Flagler County whenever possible throughout the City.

Section 3. Financial Support of Parties

- (A) Flagler County will be responsible for personnel, notification, and equipment costs related to the Agreement.
- (B) Subject to the limitations of Section 768.28, Florida Statutes, all liability for injury to personnel and for loss or damage of equipment shall be borne by the party employing such personnel and owning such equipment.
- (C) All costs associated with the operation of equipment and supplies shall be the responsibility of the acting party unless otherwise stated herein or agreed upon in writing between the parties.

Section 4. Liabilities and Responsibilities of Parties

- (A) Nothing herein shall be construed as a waiver of sovereign immunity under Section 768.28, Florida Statutes, on the part of either party to this Agreement.
- (B) Neither party hereto or its respective officers or employees shall assume any liability for the acts, omissions, or negligence of the other party or the other party's respective officers or employees.
- (C) Each party hereto will maintain their own liability insurance and worker's compensation for their employees.

Section 5. Term of Agreement

The term of this Agreement shall begin on the date the agreement is recorded with the Clerk of the Court in accordance with Section 163.01(11), Florida Statutes, and shall remain in effect until terminated by either party. Either party may terminate this Agreement by giving at least ninety (90) days written notice to the other party as provided in Section 6. herein.

ORDINANCE 2023-18

AN ORDINANCE OF THE CITY OF BUNNELL, FLORIDA AMENDING THE BUNNELL CODE OF ORDINANCE CHAPTER 50 SOLID WASTE; PROVIDING FOR BULK PICK UPS ON RESIDENTIAL PROPERTIES; PROVIDING FOR CONFLICTING PROVISIONS; PROVIDING FOR SEVERABILITY AND APPLICABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Article VIII, Section 2, *Constitution of the State of Florida*, authorizes the City of Bunnell to exercise any power for municipal purposes except as otherwise provided by law; and

WHEREAS, Chapters 166 and 163, Florida Statutes, include authority to enact regulations to protect the health, safety and welfare, and interests of the citizens of the City; and

WHEREAS, the *Bunnell Code of Ordinance* provides for solid waste regulations; and

WHEREAS, the City Commission of the City of Bunnell finds it is in the best interest and welfare of the citizens of the City to amend the solid waste regulations; and

WHEREAS, the City of Bunnell has complied with all requirements and procedures of Florida law in processing and advertising this Ordinance; and

WHEREAS, for purposes of this Ordinance, underlined type shall constitute additions to the original text, *** shall constitute ellipses to the original text and ~~strikethrough~~ shall constitute deletions to the original text.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF BUNNELL, FLORIDA AS FOLLOWS:

Section 1.

Chapter 50 of the Bunnell Code of Ordinance is hereby amended as follows:

Sec. 50-13. - Extra pick-up service.

All fees charged for extra pick-ups and bulk pick-ups on residential accounts will be determined by the solid waste director or designee. If a fee is charged for this service, the fee will be added to the next utility bill. The cost for the pick-up will vary depending on the size, weight and type of the item(s) and based on the fee established by the City Commission by resolution.

Residential accounts:

~~(1) No fees will be charged for replacement of similar type bulk items. Example: when replacing a residential rug or replacing furniture, there will be no fee charged.~~

~~(2) A small amount of construction debris may be placed out for pick-up, but may warrant a fee depending on size of the pile, weight and type of debris.~~

Section 2. Implementing Administrative Actions.

The City Manager, or designee, is hereby authorized and directed to implement the provisions of this Ordinance and to take any and all necessary administrative actions to include, but not be limited to, the adoption of administrative forms, policies, procedures, processes and rules.

Section 3. Codification.

The provisions of this Ordinance, including its recitals, shall become and be made a part of the *Bunnell Code of Ordinance* and the Sections of this Ordinance may be renumbered or re-lettered to accomplish such intention and the word "Ordinance", or similar words, may be changed to "Section," "Article", or other appropriate word; provided, however, that Sections 2, 3, 4, 5, and 6 shall not be codified. The Code codifier is granted liberal authority to codify the provisions of this Ordinance.

Section 4. Conflicts.

All ordinances or parts thereof in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5. Severability.

If any section, subsection, sentence, clause, phrase, or portion of this Ordinance, or application hereof, is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion or application shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

Section 6. Effective Date.

This Ordinance shall take effect immediately upon enactment.

Summary/Highlights:

This is an administrative proposal to amend the City's official zoning map to assign Bunnell zoning classifications consistent with the adopted Future Land Use Map to 32,583+/- acres of land held in various ownerships. This is Phase 2 of a 3-phase effort to rezone property to an appropriate Bunnell zoning classification.

In accordance with Florida Statue, letters of notification to all affected property owners regarding First Reading were mailed out on June 19, 2023. Additionally, an advertisement for this proposed ordinance for First Reading was run in the Palm Coast Observer on August 31, 2023.

Background:

The City of Bunnell annexed many thousand of acres of land into its corporate limits in 2006-2007. The City's comprehensive plan was amended to provide future land use designations for the annexed land. These new land use designations were a one-to-one translation from the Flagler County future land use designation that were already on a particular property to the closest City equivalent. The underlying Flagler County zoning was left in place. Up until Phase 1 of this rezoning effort, almost all the annexed lands still retained their obsolete Flagler County zoning. A few properties having no zoning at all are shown on the official zoning map as "ND-No Designation."

This is a problem because land without City of Bunnell zoning is not covered by the City's Land Development Code. At the same time, the city does not have the authority to administer the County's land development code. This makes the remaining Flagler County zoning essentially a holding category and this is meant that property owners have been required to go through zoning changes before they can obtain building permits. Many property owners have had planned projects significantly delayed because they had not anticipated the time and expense associated with a rezoning.

To remedy this situation, the City of Bunnell has embarked on this 3-Phase mass rezoning effort. The City's planning consultant was directed to assign proposed Bunnell zoning classifications based on the Future Land Use Map in the City of Bunnell Comprehensive Plan 2035. This is a conformance with Florida Law which requires that all land development regulations which include the zoning map to be consistent with the City's Comprehensive Plan. This item is Phase 2 of a 3-Phase mass rezoning of properties that will provide Bunnell zoning classifications for properties without City zoning. Phase 1 included those properties without City of Bunnell zoning classifications that did not have any portion of the property designated as Conservation-1 or Conservation-2 on the City's Future Land Use Map. Phase 1 was concluded in August of 2022. Phase 2 includes the non-conservation portions of the properties excluded from Phase 1. Phase 3 will address the remaining portions of the properties that do have conservation designations. It is anticipated that the scope of Phase 3 will involve changes to the City's comprehensive plan, the land development code, and the zoning map.

Staff held a community meeting on April 9, 2023. All the owners of the property included in phase 2 & 3 were notified of the workshop. At the meeting, City staff and ZevCohen & Associates personnel reviewed the annexation history of the properties, the results of Phase 1 of the mass rezoning, described the plans for phases 2 & 3 and answered questions.

Individual public hearing notices were mailed to each of the affected property owners on July 19, 2023. The notices identified the affected properties by parcel number, listed their existing City Future Land Use Map designation and obsolete Flagler County zoning classifications as well as the proposed new Bunnell zoning classification.

ORDINANCE 2023-09

AN ORDINANCE OF THE CITY OF BUNNELL, FLORIDA PROVIDING FOR THE REZONING OF REAL PROPERTY TOTALING APPROXIMATELY 32,583± ACRES WITHIN THE CITY OF BUNNELL AS DESCRIBED IN EXHIBIT “B” PROVIDING FOR THE TAKING OF IMPLEMENTING ADMINISTRATIVE ACTIONS; PROVIDING FOR THE ADOPTION OF MAPS BY REFERENCE; REPEALING ALL CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; PROVIDING FOR NON-CODIFICATION AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the properties to be rezoned are certain parcels of real property, which land totals approximately 32,583± acres, and which parcels are identified by Parcel Identification Numbers in the attached Exhibit “B”; and

WHEREAS, the City of Bunnell has petitioned to rezone said parcels of real property from various Flagler County and undesignated zoning classifications to the zoning classifications shown in Exhibit “B as corresponding to each specified parcel, all in accordance with the City of Bunnell Comprehensive Plan, and

WHEREAS, the City’s Community Department has conducted a thorough review and analysis of the general planning and land development issues should the subject rezoning be approved and has otherwise reviewed and evaluated the rezoning to determine whether it comports with sound and generally accepted land use planning practices and principles as well as whether the rezoning is consistent with the goals, objectives and policies set forth in the City’s *Comprehensive Plan*; and

WHEREAS, on August 1, 2023, the Planning, Zoning and Appeals Board of the City of Bunnell reviewed this request and recommended approval of the proposed ordinance to the City Commission; and

WHEREAS, professional City planning staff, the City’s Planning, Zoning and Appeals Board and the City Commission have determined that the proposed rezoning of the subject properties as set forth in this Ordinance is consistent with the *Comprehensive Plan of the City of Bunnell*, the land development regulations of the City of Bunnell, and the controlling provisions of State law; and

WHEREAS, the City Commission of the City of Bunnell, Florida has taken, as implemented by City staff, all actions relating to the rezoning action set forth herein in accordance with the requirements and procedures mandated by State law.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF BUNNELL, FLORIDA:

Section 1. Legislative Findings and Intent.

(a) The City Commission of the City of Bunnell hereby adopts and incorporates into this Ordinance the City staff report and City Commission agenda memorandum relating to the application relating to the proposed rezoning of the subject properties as well as the recitals (whereas clauses) to this Ordinance.

(b) The subject properties, which are approximately 32,583± acres in size, are those parcels identified by Parcel Identification Numbers as shown within Exhibit “B”.

(c) The City of Bunnell has complied with all requirements and procedures of Florida law in processing and advertising this Ordinance.

Section 2. Rezoning of Real Property/Implementing Actions.

(a) Upon enactment of this Ordinance the following described properties, as depicted in the map attached to this Ordinance, and totaling approximately 32,583± acres in size, shall be rezoned to the zoning classifications shown in Exhibit “B” as corresponding to each specified parcel and as depicted in the maps attached to this ordinance from various Flagler County and undesignated zoning classifications; and

(b) The City Manager, or designee, is hereby authorized to execute any and all documents necessary to formalize approval of the rezoning action taken herein and to revise and amend the Official Zoning Map or Maps of the City of Bunnell as may be appropriate to accomplish the action taken in this Ordinance.

(c) Conditions of development relating to the subject property may be incorporated into the subsequent pertinent development orders and such development orders may be subject to public hearing requirements in accordance with the provisions of controlling law.

Section 3. Incorporation of Maps.

The maps attached as Exhibit “A” to this Ordinance are hereby ratified and affirmed and incorporated into this Ordinance as a substantive part of this Ordinance.

Section 4. Conflicts.

All ordinances or part of ordinances in conflict with this Ordinance are hereby repealed.

Section 5. Severability.

If any section, sentence, phrase, word, or portion of this Ordinance is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Ordinance not otherwise determined to be invalid, unlawful, or unconstitutional.

Section 6. Non-codification.

This Ordinance shall be not be codified in the *City Code of the City of Bunnell* or the *Land Development Code of the City of Bunnell*; provided, however, that the actions taken herein shall be depicted on the zoning maps of the City of Bunnell by the City Manager, or designee.

Section 7. Effective Date

This Ordinance shall take effect upon adoption.

Exhibit "A" Amended Zoning Map

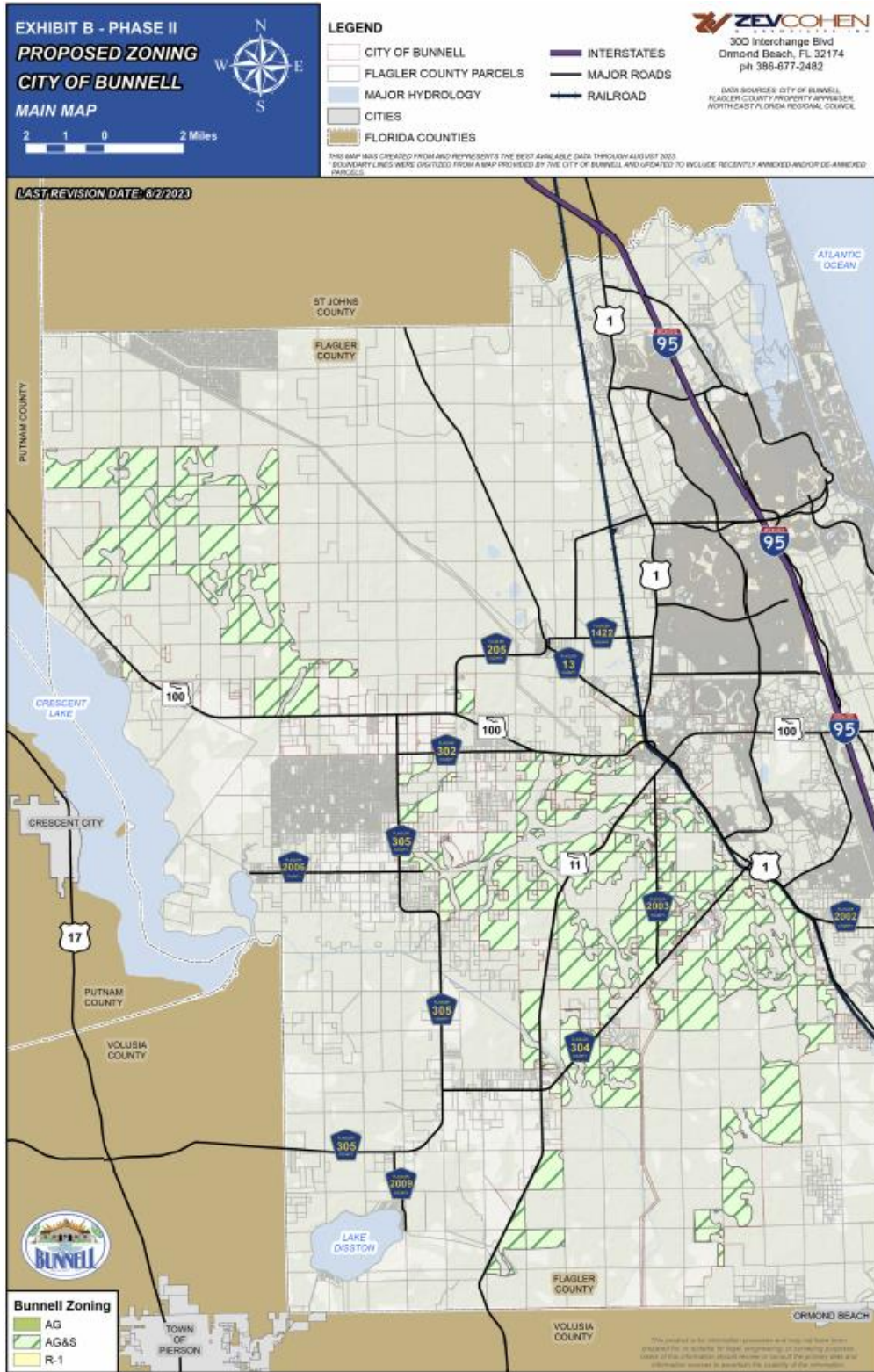

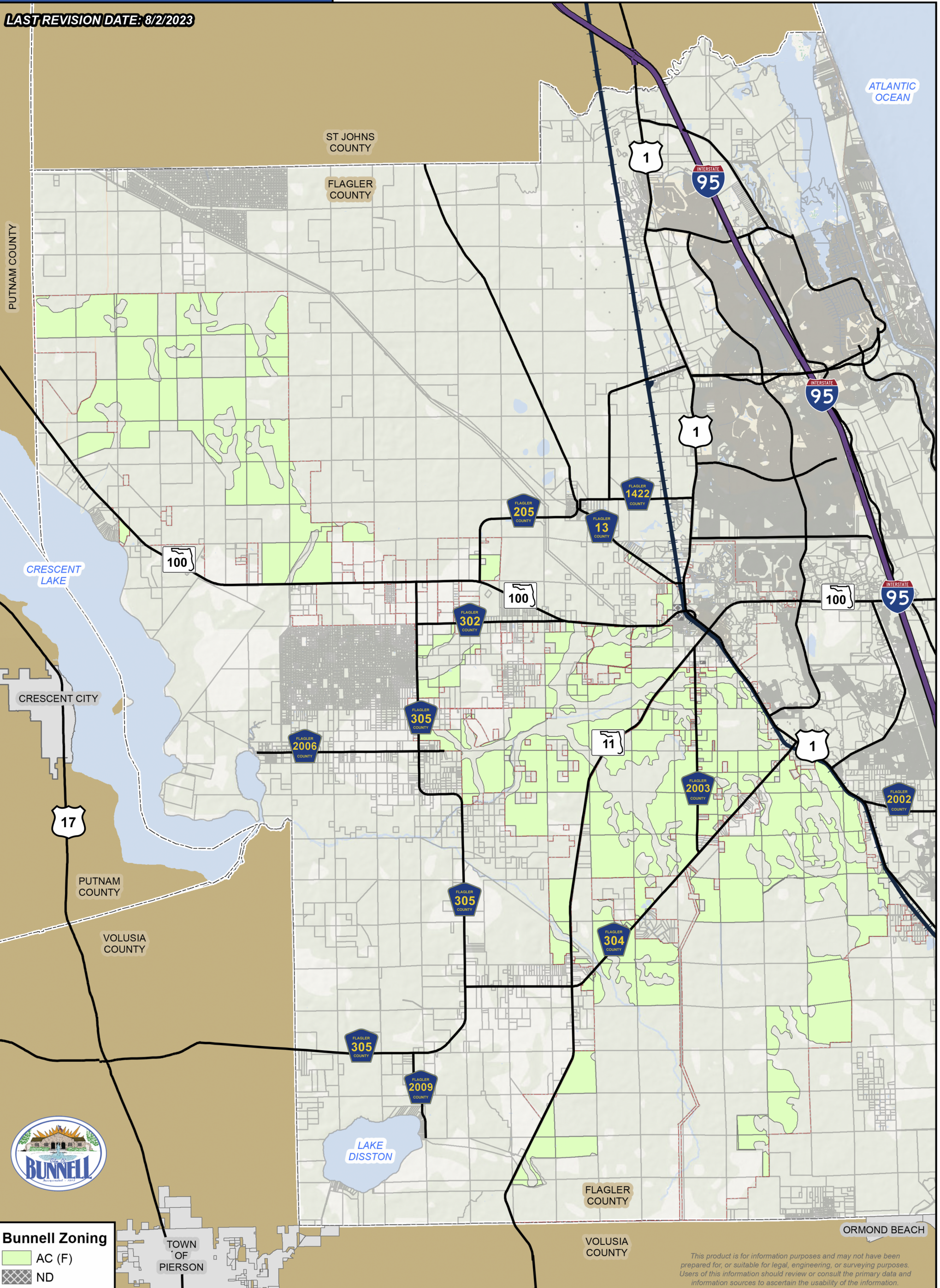

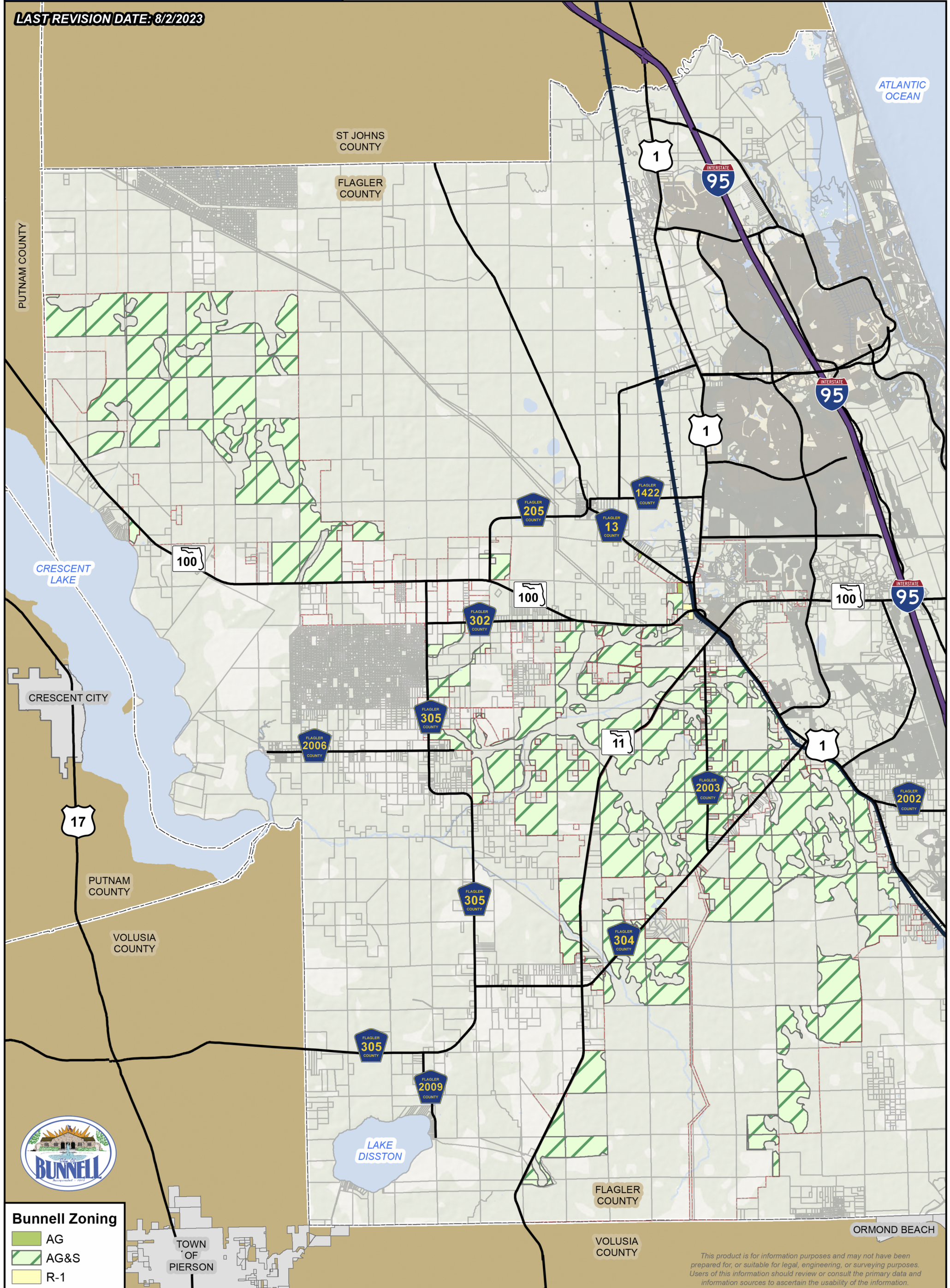

Summary/Highlights:

As required by Florida Statute, this is the first Public Hearing to consider the tentative millage rate for FY 2023/24. The millage rate being proposed is 7.93 mils which is a half a mil (.5) increase over the current year's millage rate of 7.43 mils.

Background:

The Truth In Millage (TRIM) law requires that the following be announced at the public hearing: "The Tentative Millage Rate of 7.9300 is 13.45% greater than the computed rolled-back rate of 6.9912. The Rolled-Back Rate is the millage rate that will generate the same amount of ad valorem revenues as the prior year, less the value of new construction.

The increase is being proposed for several reasons but the highlights are; 1) The City can have a structurally balanced General Fund operating budget, meaning that recurring revenues are sufficient to meet recurring expenditures 2) To implement salary and associated operating adjustments to the Police Department so we can recruit and retain qualified staff 3) Afford the rising costs of insurance 4) Fund the increase required by the Florida Retirement System.

The TRIM law also requires that the date, time and place for the Final Public Hearing for the Annual Operating Budget for FY 2023/24 to be announced. That date is September 25, 2023 at 7:00 PM at the Flagler County Governmental Services Building."

An opportunity for public comment on the proposed millage rate and tentative budget is also specifically required by statute.

For informational purposes, an attachment has been included regarding millage rate history, and an example of tax increase/decreases to citizens, and example tax bills.

WHEREAS, The Flagler County Property Appraiser has certified the quantity of taxable property within the City of Bunnell for Fiscal Year 2023-2024; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within the City of Bunnell has been certified by the Flagler County Property Appraiser as of January 1, 2023; and

WHEREAS, the City Manager has delivered the Recommended Annual Operating Budget for FY 2023-2024 in accordance with Article IV, Section 4.04 of the City Charter; and

WHEREAS, a public hearing on the proposed millage rate has been conducted by the City Commission of the City of Bunnell at 7:00 PM on September 11, 2023 and a public hearing for the final millage rate will be conducted at 7:00 PM on September 25, 2023; and

WHEREAS, the public was and will be provided an opportunity for comment at both public hearings.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF BUNNELL, FLORIDA:

Section 1:

The above "WHEREAS" clauses are incorporated by reference.

Section 2:

That the City Commission hereby adopts and imposes a tentative millage rate of 7.9300 for ad valorem taxation within the City of Bunnell, Florida for the 2023-2024 fiscal year. This tentative ad valorem tax shall be levied upon the 2023 Tax Assessment Roll for ad valorem tax on all taxable property located within the City of Bunnell and is to be used for the City's fiscal year beginning October 1, 2023 and ending September 30, 2024.

Section 3:

The ad valorem millage rate of 7.9300 to be levied upon all taxable property located within the City of Bunnell is 13.45% greater than the computed rolled-back rate of 6.9912.

Section 4:

The Final Budget Hearing is hereby set for September 25, 2023 at 7:00 PM.

Section 5:

This resolution shall become effective immediately upon its adoption.

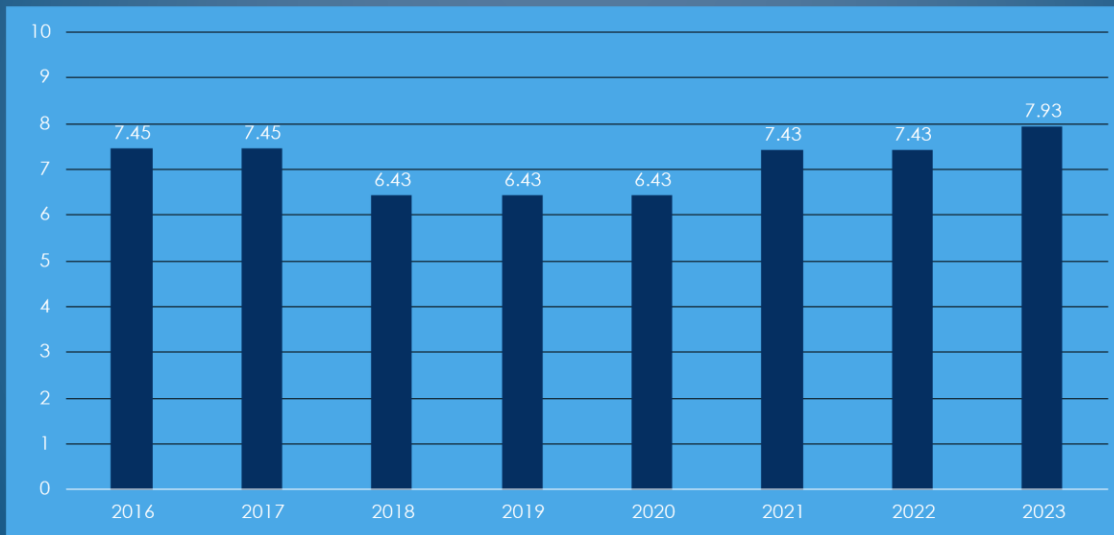

Summary/Highlights:

This is a request to approve a new contract with Environmental Land Services of Flagler County (ELS) for solid waste dumping services.

Background:

The City's current contract for solid waste dumping services expires September 30, 2023. RFP 2023-02 was released to obtain bid submittals for a new contract.

On August 28, 2023, at the Regular Meeting of the Bunnell City Commission, the City Commission authorized staff to negotiate a contract with ELS.

A draft contract has been prepared based on the fees proposed in the bid submittal from ELS. The initial contract is for a 5 year period and there are 2 options to extend the contract. INDEPENDENT CONTRACTOR'S AGREEMENT**

THIS INDEPENDENT CONTRACTOR'S AGREEMENT (hereinafter this "Agreement") is made and entered into this _____ day of September 2023, by and between **THE CITY OF BUNNELL**, a Florida municipality (hereinafter the "CITY") and **ENVIRONMENTAL LAND SERVICES OF FLAGLER COUNTY INC**, a Florida (corporation or company) authorized to do business in the State of Florida (hereinafter "CONTRACTOR").

WITNESSETH

WHEREAS, the CITY is a political subdivision of the State of Florida, having a responsibility to provide certain services to benefit the citizens of CITY; and

WHEREAS, the CITY has the full power and authority to enter into the transactions contemplated by this Agreement; and

WHEREAS, CONTRACTOR is in the business of contracting in CITY and elsewhere in the State of Florida; and

WHEREAS, CONTRACTOR is competent and has sufficient manpower, training, and technical expertise to perform the services contemplated by this Agreement in a timely and professional manner consistent with the standards of the industry in which CONTRACTOR operates; and

WHEREAS, Section 448.095, Fla. Stat., imposes certain obligations on public agencies with regard to the use of the E-Verify system by their contractors and subcontractors.

WHEREAS, CONTRACTOR submitted a proposal for an advertised RFP 2023-02 which satisfies the CITY's Procurement Policy; and

WHEREAS, CONTRACTOR agrees to provide such goods and services as more particularly described in this Agreement, as well as in any bid or quotation documents issued in connection with this project.

NOW THEREFORE in consideration of the premises, and in consideration of the mutual conditions, covenants, and obligations hereafter expressed, the parties agree as follows:

- 1. Recitals.** The foregoing recitals are true and correct, constitute a material inducement to the parties to enter into this Agreement, and are hereby ratified and made a part of this Agreement.

2. Description of Work.

- a. The CITY hereby retains CONTRACTOR to furnish services for MSW Class 1/ Class 111/ Landfill/ C&D / MRF Recycling Service/ Yard Waste Recycling/ Solid Waste Transfer/ Transportation & Disposal Services at the rates as described and attached hereto as Exhibit "A" and incorporated herein by reference. Any conflict between the terms and conditions in the body of this Agreement and the terms and conditions set forth in Exhibit "A" will be resolved in favor of the body of this Agreement.
- b. CONTRACTOR must provide all permits, labor, materials, equipment, and supervision necessary for the completion of the Scope of Services as described in RFP 2023-02, unless specifically excluded.
- c. CONTRACTOR must also comply with, and abide by, all requirements as contained in the request for proposals (RFP), bid specifications, or other similar documents issued for this service by the CITY, together with any addenda, hereinafter the "Bid Documents, as applicable." The Bid Documents, if applicable, are hereby incorporated into this Agreement by reference and are declared to be material part of this Agreement.

3. Commencement and completion/Terms.

- a. This Agreement shall be effective October 1, 2023 for an initial contract of five (5) years with the option for up to two (2) extensions of the contract in two-year increments.
- b. Amendments to the contract will be processed as needed.

4. Payment.

- a. The CITY agrees to compensate CONTRACTOR, for work actually performed under this Agreement, at the rate or basis described in Exhibit "A", which is attached hereto and incorporated herein by reference. CONTRACTOR must perform all work required by the Scope of Services, but in no event will CONTRACTOR be paid more than the negotiated amount set forth in Exhibit "A".
- b. The CITY reserves the right to ratably withhold amounts in the event of the nonperformance of all or part of CONTRACTOR's obligations. CONTRACTOR must, without additional compensation, correct and revise any errors, omissions, or other deficiencies in its work product, services, or materials arising from the error or omission or negligent act of CONTRACTOR.

5. Termination.

- a. Termination at Will: This Agreement may be terminated by the CITY in whole or in part at any time without cause by the CITY giving written notice to CONTRACTOR not less than 90 days prior to the date of termination; provided, however, that in such event, neither party will be relieved from its rights or obligations of this Agreement through the date of the actual termination. Notice

must be delivered by certified mail, return receipt requested, or in person with proof of delivery.

- b. Termination for Cause: This Agreement may be terminated by either party for cause by the CITY or CONTRACTOR giving written notice to the other party not less than 90 days prior to the date of termination; provided, however, that in such event, neither party will be relieved from its rights or obligations of this Agreement through the date of the actual termination. Notice must be delivered by certified mail, return receipt requested, or in person with proof of delivery.

6. Contract management.

- a. The Contract Managers for this project are as follows. Any subsequent changes to the Contract Manager for either party may be provided by notice as described in paragraph 8 below and does not require an amendment to this Agreement.
- b. CITY's Contract Manager for this service is: Kristen Bates, City Clerk/Administrative Services Director/PIO.
- c. CONTRACTOR's Contract Manager is: Nikki Thomas, (Title)

7. Notices. All notices to the parties under this Agreement must be in writing and sent certified mail to:

- a. To CITY: CITY CLERK PO Box 756, Bunnell, Florida 32110.
- b. To CONTRACTOR: Environmental Land Services of Flagler County Inc., Attention: Nikki Thomas (name), Operations Manager (title), 1841 N. STATE ST. BUNNELL FL (street address, City, State, Zip Code).
32110

8. Insurance.

- a. CONTRACTOR must maintain such insurance as more fully described in the Bid Documents for RFP 2023-02.
- b. CONTRACTOR must furnish the CITY with Certificates of Insurance, which are to be signed by a person authorized by that insurer to bind coverage on its behalf. The CITY is to be specifically included as an additional insured and loss payee on all policies except Workers' Compensation. In the event the insurance coverage expires prior to the completion of the project, a renewal certificate must be issued 30 days prior to the expiration date. The policy must provide a 30 day notification clause in the event of cancellation or modification to the policy. All certificates of insurance must be on file with and approved by the CITY before commencement of any work activities.
- c. The insurance coverages procured by CONTRACTOR as required herein will be considered as primary insurance over and above any other insurance, or self-insurance, available to CONTRACTOR, and any other insurance, or self-insurance available to CONTRACTOR will be considered secondary to, or in

excess of, the insurance coverage(s) procured by CONTRACTOR as required herein.

9. General Provisions. CONTRACTOR must comply with the following general provisions:

- a. Compliance with Laws.** In providing the Scope of Services, CONTRACTOR must comply with all federal, state, and local laws, statutes, ordinances, rules, and regulations pertaining to or regulating the provision of such services, including those now in effect and hereafter adopted.
- b. Personal nature of Agreement; Assignment.**
 - i. The parties acknowledge that the CITY places great reliance and emphasis upon the knowledge, expertise, training, and personal abilities of CONTRACTOR. Accordingly, this Agreement is personal and CONTRACTOR is prohibited from assigning or delegating any rights or duties hereunder without the specific written consent of the CITY.
 - ii. If CONTRACTOR requires the services of any subcontractor or professional associate in connection with the work to be performed under this Agreement, CONTRACTOR must obtain the written approval of the CITY Project Manager prior to engaging such subcontractor or professional associate. CONTRACTOR will remain fully responsible for the services of any subcontractors or professional associates.
- c. Discrimination.**
 - i. CONTRACTOR shall not discriminate against any employee employed in the performance of this Agreement, or against any applicant for employment because of age, ethnicity, race, religious belief, disability, national origin, or sex. CONTRACTOR shall not exclude any person, on the grounds of age, ethnicity, race, religious belief, disability, national origin, or sex, from participation in, denied the benefits of, or be otherwise subjected to discrimination in any activity under, this Agreement.
 - ii. CONTRACTOR shall provide a harassment-free workplace, with any allegation of harassment given priority attention and action by management.
- d. Independent contractor.**
 - i. CONTRACTOR is, and will be deemed to be, an independent contractor and not a servant, employee, joint adventurer, or partner of the CITY. None of CONTRACTOR's agents, employees, or servants are, or will be deemed to be, the agent, employee, or servant of the CITY. None of the benefits, if any, provided by the CITY to its employees, including but not limited to, compensation insurance and unemployment insurance, are available from the CITY to the employees, agents, or servants of CONTRACTOR. CONTRACTOR will be solely and entirely responsible for its acts and for the acts of its agents, employees, servants, and

subcontractors during the performance of this Agreement. Although CONTRACTOR is an independent contractor, the work contemplated herein must meet the approval of the CITY and is subject to the CITY's general right of inspection to secure the satisfactory completion thereof. CONTRACTOR must comply with all Federal, State and municipal laws, rules and regulations that are now or may in the future become applicable to CONTRACTOR, or to CONTRACTOR's business, equipment, or personnel engaged in operations covered by this Agreement or accruing out of the performance of such operations. The CITY will not be held responsible for the collection of or the payment of taxes or contributions of any nature on behalf of CONTRACTOR.

- ii. CONTRACTOR will bear all losses resulting to it on account of the amount or character of the work, or because of bad weather, or because of errors or omissions in its contract price.
- iii. CONTRACTOR must utilize, and must expressly require all subcontractors to utilize, the U.S. Department of Homeland Security's E-Verify system to verify the employment eligibility of all new employees hired by CONTRACTOR and any subcontractors during the Term of this Agreement.

e. Indemnification.

- i. CONTRACTOR must indemnify and hold the CITY harmless against and from any and all claims, losses, penalties, interest, demands, judgments, costs, damages, or expenses, including attorney's fees and court costs, incurred by the CITY, or its agents, officers, or employees, arising directly or indirectly from CONTRACTOR's performance under this Agreement or by any person on CONTRACTOR's behalf, including but not limited to those claims, losses, penalties, interest, demands, judgments, costs, damages, or expenses arising out of any accident, casualty, or other occurrence causing injury to any person or property. This includes persons employed or utilized by CONTRACTOR (including CONTRACTOR's agents, employees, and subcontractors). CONTRACTOR must further indemnify the CITY against any claim that any product purchased or licensed by the CITY from CONTRACTOR under this Agreement infringes a United States patent, trademark, or copyright. CONTRACTOR acknowledges that CONTRACTOR has received consideration for this indemnification, and any other indemnification of the CITY by CONTRACTOR provided for within the Bid Documents, the sufficiency of such consideration being acknowledged by CONTRACTOR, by CONTRACTOR's execution of this Agreement. CONTRACTOR's obligation will not be limited by, or in any way to, any insurance coverage or by any provision in or exclusion or omission from any policy of insurance, whether such insurance is in connection with this Agreement or otherwise. Such indemnification is in addition to any and all other legal remedies available to the CITY and not considered to be the CITY's exclusive remedy.

- ii. In the event that any claim in writing is asserted by a third party which may entitle the CITY to indemnification, the CITY must give notice thereof to CONTRACTOR, which notice must be accompanied by a copy of statement of the claim. Following the notice, CONTRACTOR has the right, but not the obligation, to participate at its sole expense, in the defense, compromise or settlement of such claim with counsel of its choice. If CONTRACTOR does not timely defend, contest, or otherwise protect against any suit, action or other proceeding arising from such claim, or in the event the CITY decides to participate in the proceeding or defense, the CITY will have the right to defend, contest, or otherwise protect itself against same and be reimbursed for expenses and reasonable attorney's fees and, upon not less than ten (10) days notice to CONTRACTOR, to make any reasonable compromise or settlement thereof. In connection with any claim as aforesaid, the parties hereto must cooperate fully with each other and make available all pertinent information necessary or advisable for the defense, compromise or settlement of such claim.
 - iii. The indemnification provisions of this paragraph will survive the termination of this Agreement.
- f. **Sovereign Immunity.** Nothing in this Agreement extends, or will be construed to extend, the CITY's liability beyond that provided in section 768.28, Florida Statutes. Nothing in this Agreement is a consent, or will be construed as consent, by the CITY to be sued by third parties in any matter arising out of this Agreement.
- g. **Public records.**
- i. CONTRACTOR is a "Contractor" as defined by Section 119.0701(1)(a), Florida Statutes, and must comply with the public records provisions of Chapter 119, Florida Statutes, including the following:
 - 1. Keep and maintain public records required by the CITY to perform the service.
 - 2. Upon request from the CITY's custodian of public records, provide the CITY with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in Chapter 119 or as otherwise provided by law.
 - 3. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of this Agreement term and following completion of the Agreement if CONTRACTOR does not transfer the records to the CITY.
 - 4. Upon completion of this Agreement, transfer, at no cost, to the CITY all public records in possession of CONTRACTOR or keep and maintain public records required by the CITY to perform the service. If CONTRACTOR transfers all public records to the CITY

upon completion of this Agreement, CONTRACTOR must destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If CONTRACTOR keeps and maintains public records upon completion of this Agreement, CONTRACTOR must meet all applicable requirements for retaining public records. All records stored electronically must be provided to the CITY, upon request from the CITY's custodian of public records, in a format that is compatible with the information technology systems of the CITY.

- ii. "Public records" is defined in Section 119.011(12), Florida Statutes, as may, from time to time, be amended.
- iii. If CONTRACTOR asserts any exemptions to the requirements of Chapter 119 and related law, CONTRACTOR will have the burden of establishing such exemption, by way of injunctive or other relief as provided by law.
- iv. CONTRACTOR consents to the CITY's enforcement of CONTRACTOR's Chapter 119 requirements, by all legal means, including, but not limited to, a mandatory injunction, whereupon CONTRACTOR must pay all court costs and reasonable attorney's fees incurred by CITY.
- v. CONTRACTOR's failure to provide public records within a reasonable time may be subject to penalties under Section 119.10, Florida Statutes. Further, such failure by CONTRACTOR will be grounds for immediate unilateral cancellation of this Agreement by the CITY.

- h. **Federal or State Funding.** If any portion of the funding for this Agreement is derived from the State of Florida, or any department of the State of Florida, or from federal funding through the State of Florida, the provisions of this subparagraph shall apply, provisions elsewhere in this Agreement to the contrary notwithstanding. CONTRACTOR shall make inquiry from the CITY's Project Manager to determine whether Federal or State funding is applicable to this Agreement.
 - i. Agency. CONTRACTOR agrees and acknowledges that it, its employees, and its subcontractors are not agents or employees of the

- Federal Government, of the State of Florida, or of any department of the Federal Government or the State of Florida.
- ii. Indemnification. To the fullest extent permitted by law, CONTRACTOR shall indemnify and hold harmless the CITY, the Federal Government, the State of Florida, any department of the Federal Government or the State of Florida, and all officers and employees, from liabilities, damages, losses and costs, including, but not limited to, reasonable attorney's fees, to the extent caused by the negligence, recklessness or intentional wrongful misconduct of CONTRACTOR and persons employed or utilized by CONTRACTOR in the performance of this Agreement. This indemnification shall survive the termination of this Agreement. Nothing contained in this paragraph is intended to nor shall it constitute a waiver of the State of Florida and the CITY's sovereign immunity.
 - iii. Workers' Compensation Insurance. CONTRACTOR must provide Workers' Compensation Insurance in accordance with Florida's Workers' Compensation law for all employees. If subletting any of the work, CONTRACTOR must ensure that the subcontractor(s) have Workers' Compensation Insurance for their employees in accordance with Florida's Workers' Compensation law. If using "leased employees" or employees obtained through professional employer organizations ("PEO's"), CONTRACTOR must ensure that such employees are covered by Workers' Compensation insurance through the PEO's or other leasing entities. CONTRACTOR must ensure that any equipment rental agreements that include operators or other personnel who are employees of independent Contractors, sole proprietorships or partners are covered by insurance required under Florida's Workers' Compensation law.
 - iv. Liability Insurance. Contractor shall carry Commercial General Liability insurance providing continuous coverage for all work or operations performed under the Agreement. The coverage afforded to the State of Florida as an Additional Insured shall be primary as to any other available insurance and shall not be more restrictive than the coverage afforded to the Named Insured. The limits of coverage shall not be less than \$1,000,000 for each occurrence and not less than a \$5,000,000 annual general aggregate, inclusive of amounts provided by an umbrella or excess policy. The limits of coverage described herein shall apply fully to the work or operations performed under the Contract, and may not be shared with or diminished by claims unrelated to this Agreement. The policy/ies and coverage described herein may be

subject to a deductible. CONTRACTOR shall pay all deductibles as required by the policy. No policy/ies or coverage described herein may contain or be subject to a Retention or a Self-Insured Retention. At all renewal periods which occur prior to final acceptance of the work, the CITY and the State of Florida shall be provided with an ACORD Certificate of Liability Insurance reflecting the coverage described herein. The CITY and the State of Florida shall be notified in writing within ten days of any cancellation, notice of cancellation, lapse, renewal, or proposed change to any policy or coverage described herein. The CITY's or the State of Florida's approval or failure to disapprove any policy/ies, coverage, or ACORD Certificates shall not relieve or excuse any obligation to procure and maintain the insurance required herein, nor serve as a waiver of any rights or defenses the CITY or the State of Florida may have.

- v. Inspections. CONTRACTOR shall permit, and require its subcontractors to permit, the CITY's and the State of Florida's authorized representatives to inspect all work, materials, payrolls, and records, to audit the books, records, and accounts pertaining to the financing and development of the Services described in the Contract Documents.
- vi. Auditor General Cooperation. CONTRACTOR shall comply with §20.055 (5), Florida Statutes, and shall incorporate in all subcontracts the obligation to comply with §20.055 (5), Florida Statutes.
- i. **E-Verify Compliance.** Contractor affirmatively states, under penalty of perjury, that in accordance with Section 448.095, Fla. CONTRACTOR recognizes that any representations, statements, or negotiations made by the CITY staff do not suffice to legally bind the CITY in a contractual relationship unless they have been reduced to writing, authorized, and signed by the authorized CITY representatives.

- c. **Amendment.** No modification, amendment, or alteration in the terms or conditions of this Agreement will be effective unless contained in a written document executed with the same formality as this Agreement.
- d. **Severability.** If any term or provision of this Agreement is held, to any extent, invalid or unenforceable, as against any person, entity, or circumstance during the Term hereof, by force of any statute, law, or ruling of any forum of competent jurisdiction, such invalidity will not affect any other term or provision of this Agreement, to the extent that the Agreement will remain operable, enforceable, and in full force and effect to the extent permitted by law.
- e. **Construction.** If any provision of this Agreement becomes subject to judicial interpretation, the court interpreting or considering such provision should not apply the presumption or rule of construction that the terms of this Agreement be more strictly construed against the party which itself or through its counsel or other agent prepared it. All parties hereto have participated in the preparation of the final form of this Agreement through review by their respective counsel, if any, or the negotiation of specific language, or both, and, therefore, the application of such presumption or rule of construction would be inappropriate and contrary to the intent of the parties.
- f. **Headings.** All headings in this Agreement are for convenience only and are not to be used in any judicial construction or interpretation of this Agreement or any paragraph.
- g. **Waiver.** The indulgence of either party with regard to any breach or failure to perform any provision of this Agreement does not constitute a waiver of the provision or any portion of this Agreement, either at the time the breach or failure occurs or at any time throughout the term of this Agreement. The review of, approval of, or payment for any of CONTRACTOR's work product, services, or materials does not operate as a waiver, and should not be construed as a waiver, of any of the CITY's rights under this Agreement, or of any cause of action the CITY may have arising out of the performance of this Agreement.
- h. **Force Majeure.** Notwithstanding any provisions of this Agreement to the contrary, the parties will not be held liable if failure or delay in the performance of this Agreement arises from fires, floods, strikes, embargos, acts of the public enemy, unusually severe weather, out break of war, restraint of government, riots, civil commotion, force majeure, act of God, or for any other cause of the same character which is unavoidable through the exercise of due care and beyond the control of the parties. This provision does not apply if the "Scope of Services" of this Agreement specifies that performance by CONTRACTOR is specifically required during the occurrence of any of the events herein mentioned.

- i. **Compliance/Consistency with Scrutinized Companies Provisions of Florida Statutes.** Section 287.135(2)(a), Florida Statutes, prohibits a company from bidding on, submitting a proposal for, or entering into or renewing a contract for goods or services of any amount if, at the time of contracting or renewal, the company is on the Scrutinized Companies that Boycott Israel List, created pursuant to section 215.4725, Florida Statutes, or is engaged in a boycott of Israel. Contractor further hereby certifies that Contractor is not engaged in a boycott of Israel or engaged in business operations in Cuba or Syria. Contractor understands that pursuant to section 287.135, Florida Statutes, the submission of a false certification may subject Contractor to civil penalties, attorney's fees, and/or costs. Contractor further understands that any contract with CITY for goods or services of any amount may be terminated at the option of CITY if Contractor (i) is found to have submitted a false certification, (ii) has been placed on the Scrutinized Companies that Boycott Israel List, or (iii) is engaged in a boycott of Israel. And, in addition to the foregoing, if the amount of the contract is one million dollars (\$1,000,000) or more, the contract may be terminated at the option of CITY if the company is found to have submitted a false certification, has been placed on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, or has been engaged in business operations in Cuba or Syria.
- j. **Law; Venue.** This Agreement is being executed in Bunnell, Florida and is governed in accordance with the laws of the State of Florida. Venue of any action hereunder will be in a court of competent jurisdiction within Flagler County and the City of Bunnell, Florida.

11. Special Provisions.

- a. This Agreement is a non-exclusive contract; the CITY is not prohibited, or deemed to be prohibited, from bidding similar services either as an independent job or a component of a larger project.

- 1) Question 1: Can you give us a sample for the pricing sheet on Bunnell: *Addendum 1* MSW Class 1/ Class 111/ Landfill/ C&D / MRF Recycling Service/ Yard Waste Recycling/ Solid Waste Transfer/Transportation & Disposal Services?

Answer 1: The City does not use a set format or form for pricing. The fee schedule/cost sheet/pricing sheet provided in the Bid response should clearly identify the cost per yard/ton, cost per item, or however else disposal of solid waste, recycling, yard waste or construction debris may be charged by the responder. Any additional fees, such as fuel surcharges or any other possible fees that could be added to a dump ticket or invoice due to the service provided should be included in the fee schedule/cost sheet/pricing sheet.

- 2) Question 2: How does the City collect recycling materials?

Answer 2: The City collects recycling as single sort material. The City does not have the equipment or staff to collect materials already separated to deliver to the transfer site; items collected by City trucks will be delivered combined in one truck. The City does residential single stream garbage and recycling collection (all garbage/recycling goes into one toter/cart issued by the City and is dumped into the same truck).

Clean commercial cardboard is collected by the City.

Commercial dumpster service is provided by the City.

In 2021, due to industry standards, the City had to alter its recycling program. At this time the following materials are collected for residential recycling: clean cardboard and aluminum; however, the City would like to resume the collection and processing of glass and plastics as part of the recycling program. Any bidder should include information on the types of materials they can/will take for recycling.

The City does not collect hazardous household goods on a regular basis. The City may wish to host a hazardous household waste collection day(s) and therefore is seeking rates for the disposal of these types of waste.

The City averages about 16-18 visits per week to our current provider to empty trucks.

4) Question 4: Where is the City delivering each of these waste streams to today?

Answer 4: The City's current contract is with Environmental Land Services LLC 1841 North State St., Bunnell, FL 32110.

The City has no other contracts for disposal of solid waste or recycling. For items not accepted by the current provider the City has used the following: Global Tire Recycling 1201 Industrial Dr., Wildwood, FL 34785.

- 5) Question 5: What is the current rate for disposal and/or processing the City currently pays for each waste stream?

Answer 5: Under the City's current contract, the City pays \$6.00 per cubic yard for yard waste, \$48.75 per ton for solid waste disposal and \$48.75 per ton for construction and debris disposal.

The City started paying a \$500.00 per week fuel surcharge in September 2022. This was due to rising fuel prices experienced by the current contractor, but was not considered to be a permanent charge and could be stopped once fuel prices are lowered further.

Per the original 2015 contract, there is a \$20.00 per ton rebate for clean cardboard; however, this rebate fluctuates based on the market rate.

- 6) Question 6: Based on the question and answer in Addendum NO.01 will the city provide a complete list of any multifamily and commercial customers it services as well as the number of single-family homes it collects from.

Answer 6: The table below reflects the number of solid waste accounts as of May 2023:

Note: The City is in several due diligence discussions with developers that will significantly increase the number of solid waste accounts, both residential and commercial, over the next 1 to 5 years.

- 7) Question 7: What are the services and frequencies for each waste stream the City provides to the residents?

Answer 7: Residential customers receive the following pick-ups per week: 1 yard waste, 2 solid waste, 1 recycling and 1 bulk pick-up.

Commercial carts are picked up once a week.

Commercial dumpsters can be picked up once, twice or three times per week.

Commercial cardboard is picked up once a week.

- 8) Question 8: Will the City provide a pricing format for the disposal portion for the bidders to respond with. If the City provides the form, it will create a uniform response.

Answer 8: The City is not issuing a pricing form for bid submittal (see question and answer 1 Addendum No. 02). Please provide the cost to dispose of items per ton or yard, whichever is applicable to the item type accepted by the bidder. If there are other possible fees or costs associated with the use of the dumping site, they need to be listed.

- 9) Question 9: Will the City extend the due date to allow time for bidders to adjust bids based on answers to questions submitted?

Answer 9: The bid due date will not be extended.

- 10) Question 10: Please explain ADA compliant electronic copy in pdf format.

Answer 10: ADA compliant means the document and any images have been converted to be readable to an e-reader.

- 11) Question 11: Please provide average daily, weekly, and yearly volumes of MSW Class 1. Please provide average daily, weekly, and yearly volumes of Class 111. Please provide average daily, weekly, and yearly volumes of Construction and Demolition debris. Please provide average daily, weekly, and yearly volumes of Recycling. Please provide average daily, weekly, and yearly volumes of Yard Waste. Please provide average daily, weekly, and yearly volumes of Tire Disposal. Please provide average daily, weekly, and yearly volumes of Solid Waste for transfer.

Answer 11: See charts provided in Addendum 02 Question 3. To provide this information for daily, weekly and yearly data would take an extended period of time to gather and organize for an answer which would delay the posting of the addendum and give potential responders less time to prepare and submit their bids.

12) Question 12: Please provide average daily, weekly, and yearly volumes of Household Hazardous Waste.

Answer 12: The City has never gathered household hazardous waste on its own; we have partnered with adjacent jurisdictions to host household hazardous waste collection days. There is no data to provide.

13) Question 13: Please explain How materials are delivered, i.e., type of truck, etc.

Answer 13: Currently the City operates two (2) solid waste trucks- a 2010 Mack LEU613 and a 2019 Peterbuilt 520- and one grapple truck- 2023 Freightliner M2. Materials are collected and delivered in all these trucks; dumped from the body of each truck.

14) Question 14: Are tires delivered in a separate truck?

Answer 14: Tires are delivered in their own load; only tires in the entire truck. They are delivered using the grapple truck.

15) Question 15: How are furniture, bulk, and appliances delivered, i.e., flatbed truck

Answer 15: All bulk and construction debris are gathered with the grapple truck and delivered in the same truck. Depending on the route ad items placed out for pickup, furniture and construction debris may be delivered in the same load.

16) Question 16: Is the City looking for a site to hold "Hazardous Waste" days twice per year?

Answer 16: The City has not determined if it wishes to hold these collection days. The City is looking to explore hosting these types of says one or twice a year.
