County Attorney Eckstine stated staff has been searching for a procedure to address the dangerous dog hearing situation where evidence can be taken by a hearing officer, who would be a trained attorney, in preparing a proposed recommended order that would contain findings of fact and conclusions of law. Stated the matters would then come before this Board to hear oral arguments in favor of and opposition to that proposed recommended order. Stated the Board would not be delegating its power to make a decision, it would be delegating only preliminary fact finding matters.

Stated he spoke with County Planning Director Koch about the possibility of including other matters, particularly in the land development area, and at this time he has not identified any that would be appropriate for such a procedure.

Stated his recommendation would be to put the structure in place, assemble a list of qualified hearing officers, and if at a later time the Board determined that this is a successful procedure and wanted to treat other matters in that way it certainly would be an easy procedure to implement.

Chairman Darby opened the Public Hearing.

There were no public comments.

Chairman Darby closed the Public Hearing.

Commissioner King stated he would support using the ordinance to address dangerous dog hearings, but was somewhat hesitant about adding land use or anything of that nature.

A motion was made by Commissioner King to accept the proposed ordinance as written, and any addendums that may be added to the ordinance be brought back to the Board for further discussion. Seconded by Commissioner Kanbar.

Mr. Eckstine stated Section 8 as currently written does limit the application of the ordinance to dangerous dog classifications, and such other matters as the Board shall from time to time designate.

Chairman Darby called the question. No nay votes, motion carried.

County Attorney Eckstine stated the genesis of this ordinance was the last "dangerous dog" hearing which the Board heard for a period of about 2½ hours. Stated his understanding at the time was that the Board wanted the County Attorney's office to explore the possibility of a more focused proceeding. Essentially this proposed ordinance provides that the County Attorney will have the responsibility for assembling a list of attorneys who are willing to serve as hearing officers for matters such as this or anything the Board might want to add from time to time to this same procedure. Stated the hearing officer would hear evidence and then prepare a recommended order for the Board with findings of fact, conclusions of law and a recommended disposition. Stated the procedure before the Board would then be limited to arguments in support of and in opposition to the recommended order.

Chairman Darby opened the Public Hearing.

There were no public comments.

Chairman Darby closed the Public Hearing.

Commissioner Seay stated this proposed ordinance goes a long way toward protecting the rights of the County's citizens, the dog owners and the dog.

A motion was made by Commissioner Seay to approve Item 6. Seconded by Commissioner Kanbar. No nay votes, motion carried.
