Baker Act/70378-17/Faith Lane, Palm Coast/Sector 212 /A mother of an adult female called advising her daughter was screaming that she wanted to die. The female was secured for a Baker Act and transported to Act.

Weapons Complaint/70384-17/ Barrister Lane, Palm Coast/Sector 214 /911 calls came in regarding shots being heard in the area between Burnell Drive and Barrister Lane. While canvassing, units found 2 adult males. One was transported for questioning. The other was charged with reckless discharge of a firearm and possession/use of firearm while under the influence of alcohol.

Suspicious Person (x2)/70414-17/Bridgehaven Drive/Bren Mar/Sector 214 /Law Enforcement came across 2 white males at the above intersection handling fence pieces in the middle of the road. Once lit up by a marked unit spot light, they took off in separate directions. Defendant 1 (D-1) was combative, uncooperative, and intoxicated. He dropped several fence pieces along with a multi-purpose tool on the ground. D-1 was unable to clearly explain what he was doing in the area. A check of nearby homes was conducted to see if the top pyramid type fence pieces were missing, and 3 homes were found nearby. All fence pieces were installed and all matched perfectly. The other male who fled the scene was not found. D-1 was transported to the jail for L&P, petit theft, and resisting without violence.
