#### **Case Narrative**

On November 9, 2021 at approximately 1620 hours, I, Deputy Horler, responded to 1 Angela Drive, Palm Coast, Florida in reference to a school complaint.

Upon arrival, I made contact with Flagler County school board member Jill Woolbright. Jill stated that she just recently became aware that a book (All boys aren't blue) is currently in circulation, in the media centers, at four Flagler county schools. Jill further advised the book is a memoir manifesto and is at the following schools, Flagler Palm Coast High (two books), Matanzas High school (1 book), and Buddy Taylor Middle School (1book). Two of the books were currently checked out. Jill proceeded to stated she checked out he book from a public library. Jill did not read the entire book however, she was upset about chapters eleven and twelve. Chapter 11 discusses in detail, and very descriptive, about masturbation and oral sex. Chapter 15 "Losing my virginity twice" is also very descriptive and discusses masturbation, oral sex, and sodomy.

On November 2, 2021 Jill addressed the book with the school superintendent and requested the subject be addressed at a school board workshop meeting. Jill wished to discuss the content of material in the curriculum and policy on banned books. Jill was advised she needed three votes and did receive the three votes. Two other individuals were against. The next day, Jill met with the superintendent during the weekly meeting. Jill had googled the material and presented a video of another parent discussing the book.

Jill states it is a crime to have the book in the media centers and believes there are other books with similar content. Jill believes whoever is responsible for allowing the books into the Flagler County Schools media centers should be held accountable.

Jill advised the reason she contacted the Flagler County Sheriff's Office is because the superintendent has not notified the other school board members. Two of the books have been pulled from the shelves and another unknown person provided Jill one of the books. One book is still currently checked out by another person. Jill was advised by the school board attorney that the other board members would be made aware. As of today's date, Jill advised the other school board members have not been made aware by an email.

Jill gave me the book she had, from Flagler Palm Coast High School, and requested for it to be submitted into evidence. Jill advised that the Buddy Taylor Middle School media specialist is a member of "LIT" and is responsible for obtaining the books into the media center.

Investigation was reordered on Axon and the book (All boys aren't blue) will be submitted into evidence at the Flagler County Sheriff's Office. Jill was provided a voluntary statement form. Jill advised due to the length of the narrative, she would contact the Sheriff's Office when her statement was completed.

No further information at this time.
