**ORDER ON NONCOMPLIANCE WITH AN ORDER OF THE CONTRACTOR  
REVIEW BOARD**

This cause came before the Court on February 4, 2019, for hearing in the above-styled case on Plaintiff's Uniform Code Citation for noncompliance with an Order of the Flagler County Contractor Review Board. The Defendant was present, and Flagler County was represented by Sean S. Moylan, Assistant County Attorney. The Court having heard arguments of the parties, as well as having reviewed County Ordinances and the Order of the Contractor Review Board, and being otherwise advised in the premises,

**IT IS HEREBY ORDERED:**

1. Beginning in February 2019, the Defendant shall pay at least two hundred dollars (\$200.00) prior to the end of each calendar month via check or money order to Frances Parker. The Defendant shall mail the payments to Frances Parker, P.O. Box 351192, Palm Coast, FL 32135. The Defendant shall continue to make monthly payments until the Defendant has paid a total of one thousand five hundred dollars (\$1,500.00) restitution in compliance with

the Order of the Flagler County Contractor Review Board.

2. The Defendant shall also furnish proof of each payment of restitution to the Clerk of the Flagler County Contractor Review Board, whose office is in the first floor of the Government Services Building in Bunnell. Such proofs shall be filed with the Court to confirm compliance with this Court's order.
3. The Defendant also is ordered to pay, after completing the full payment of restitution to Ms. Parker, at least two hundred dollars (\$200.00) prior to the end of each calendar month to the Flagler County Board of County Commissioners. The Defendant shall remit these payments to Flagler County Central Permitting on the first floor of the Government Services Building in Bunnell. The Defendant shall continue to make monthly payments to Flagler County until the Defendant has paid the entire five hundred dollar (\$500.00) fine imposed by the Order of the Flagler County Contractor Review Board. A copy of a proof of the payments shall be filed with the Court to confirm compliance with this Court's order.
4. The fine of thirty dollars (\$30.00) imposed by Uniform Code Citation 2019010008 is hereby suspended pending compliance with the foregoing payment requirements. Flagler County will file a Notice of Compliance when the Defendant has complied with all aspects of this Order, at which time the Uniform Code Citation will be extinguished.
5. The Court will retain jurisdiction of this matter to further enforce the obligations assessed against Defendant.
