2018-79469	APC	S. Flagler Avenue	Contact was made with S1 and he was confirmed to still reside there. No suspicious activity observed.
2018-79644	Disturbance-Physical	Parkview Dr	Complainant (C1) is group home manager at this location. C1 advised adult male with mental incapacities became enraged and began throwing items at other subjects in the group home. Due to the circumstances, Adult male transported to Halifax by Law Enforcement under a Baker Act.
2018-79478	Trespassing	Patric Dr.	(Originally called in as a residential burglary) Homeowner reported a B/M attempting to exit his home. Homeowner detained the subject until Deputies arrived on scene. It was determined the subject was invited into the home, the previous night by the homeowner's 16 YOA daughter. The homeowner requested S1 be trespassed from the residence.

2018-79600	Disturbance Verbal	Bracken Ln	Female called 3rd party, advising her adult daughter (O1) called her stating her ex-boyfriend (O2) was at the residence banging on the front door. Upon the arrival of Deputies, O2 was walking towards his vehicle in the driveway. O2 stated he returned to collect his prescription medication and was leaving to travel to Pennsylvania to live. Contact attempted at the front door with O1, but she refused to come to the door. Parties separated, and the incident was verbal only.
2018-79488	Disturbance-Domestic (Verbal)	Palm Harbor Pkwy	Female (O1) advised she has been married to her husband (O2) for appx 1 month after only knowing each other a week prior to being married. O1 stated she left the residence last night because she and (O2) have been arguing a lot. Upon O1 returning to gather her belongings O1 and O2 began arguing again. Both parties advised they were verbal only, and there was no violence or threat of violence. Both parties advised they would be seeking assistance to end the marriage, and parted ways.
2018-79356	Follow-up	Cheryl Elaine Drive	An ALPR that was located on S. US1 hit on a vehicle that was being driven by S1, Nightshift previously passed on charges for S1 for violation of no contact order. Dispatch immediately notified

Deputy Archer who was in Bunnell and observed S1 vehicle driving north on US1 in the area of the North Jiffy. A traffic stop was conducted and S1 was placed under arrest and transported to the Flagler County Imamate Facility. Duane was also charged with driving on a suspended license.
