Fraud / 18-6348 / McDonalds 2 Old Kings Rd. / Sector 216

V1 states he came to Palm Coast with his cousin to sell a set of car speakers to S1. V1 said that S1 answered his add on Craigslist and agreed to meet him at the Mc Donald's at 2 Old Kings Rd. V1 said S1 gave him 12 fraudulent \$100 bills for the car speakers and quickly left the area. V1 followed S1 south on Old Kings Rd. and onto Old Dixie Hwy. where they were stopped by Deputies. S1 advised he paid for the speakers with cash he received from his bank. He said he gave V1 10 \$100 bills and 4 \$50 bills. The fraudulent bills were clearly marked with REPLICIA, THIS NOTE IS NOT LEGAL IT IS TO BE USED FOR MOTION PICTURES. The fraudulent bills and speakers were placed into evidence. Sgt. Davis contacted ISD Cmdr. Jen Taylor.

Disturbance Domestic/ 18-6381/ Putter Dr/ Sector 225
