S1 was observed leaving Raemoor Drive by Deputies on foot carrying a backpack when he was stopped on Ravenwood Drive for a pedestrian violation. S1 refused to stop for law enforcement and fled on foot where he was apprehended after a brief foot pursuit. A search incident to arrest revealed a total of 7 baggies of cocaine, 1 baggie of an unknown substance, a scale with cocaine residue, and a fraudulent \$50 bill. S1 was charged with loitering and prowling, resisting arrest without violence, possession of cocaine with intent to sell, and possession of counterfeit currency.
