Disturbance with Weapons/ 2017-90031/ Prince Eric Drive, Palm Coast/ The reporting person, O1, stated that he was working at a house under construction when O2 approached the residence with a gun, stating "I'm going to kill you" and then fired several shots in an unknown direction. Units established a perimeter and called O2 and additional occupants from within the home outside without incident. O1's statements then began changing and conflicted with witness statements and physical evidence on scene. It was later determined that no crime occurred and no charges were filed at this time. Narcotics/ 2017-90037/ Prince Eric Drive, Palm Coast/ While investigating the above incident, consent to search several subjects was obtained and approximately 72 grams of Hashish was located in the backpack of S1.
