Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons

Domestic Disturbance/ 2017-90257/ Westhampton Drive, Palm Coast/ Sector 221/ V1 stated that she was in an argument with her father, S1, when he pushed her. V1's teenage son witnessed the incident and provided the same statement at V1. S1 was arrested in reference to domestic battery and transported to the Detention Services Division without incident. See report by Deputy Shaughnessy for further.

Domestic Disturbance/ 2017-90252/ Bird Of Paradise Drive, Palm Coast/ Sector 214/ V1 stated that S1 struck her earlier in the day and her story was consistent with that of one of her teenage children that witnessed the incident. S1 was arrested in reference to felony battery (one prior conviction) and transported to the Detention Services Division without incident. A Baker Act form was left at the jail due to S1's threats of suicide. See report by Deputy Colson for further.

Crash W/Injuries/ 2017-90321/ 288 MM I95 South/ Sector 216/ A truck was traveling southbound in the left lane when it went off the roadway to the left. The truck collided with the guardrail then spun out of control to the right where it traveled off the roadway and crashed into a tree. Adult driver was pinned inside the truck and it took approximately one hour to extricate him. An infant traveling in a car seat was also inside but did not suffer any injuries. The driver was transported to Halifax Medical Center by ground, investigation turned over to FHP.

Crash W/Injuries/ 2017-90325/ 288 MM I95 South/ Sector 216/ While units were working the above crash, a secondary crash occurred in the left lane. A vehicle traveling in the left lane at a high rate of speed failed to slow down for traffic and crashed into the rear of a mini-van. One female occupant was transported to FHF for minor injuries. All lanes of I95 Southbound were shut down for a short period of time to clear the roadway. See report by Dep. Shaughnessy for further
