Death / 2017-93264 / Arena Lake Drive, Palm Coast / Sector 216 / A 47 year old female was found unresponsive by a friend. Deputy Champion and paramedics performed CPR, unsuccessfully. The female did not have any known medical history and no evidence of suspicious activity was found at the scene during the investigation. See report by Deputy R. Finn for further.

Domestic Disturbance (Physical)/ 2017-93335/ Palm Harbor Parkway (European Village)/ Sector 211/ Victim (V1) who stated that suspect, S1, had been "beating" her for the last several days and took her cell phone from her where she couldn't call law enforcement. While interviewing V1, S1 was observed walking through the courtyard at European Village. Deputies engaged in a foot pursuit and Deputy Colson apprehended the suspect without incident. S1 was arrested and charged with domestic battery, tampering with a witness, and resisting without violence. See report by Deputy Colson.

Domestic Disturbance (Physical)/ 2017-93392/ Ryland Drive, Palm Coast/ Sector 222/ V1 stated that she was in a verbal altercation with her adult son, S1, when S1 stated "I'm going to hurt you bitch" and threw a jug of tea at her. S1 was arrested in reference to Domestic Assault and transported to the inmate facility without incident. See report by Deputy Crego for further.

Suspicious Incident/ 2017-93406/ Parkview Drive, Palm Coast/ Sector 225/ RP stated that she was sitting in her vehicle smoking a cigarette at approximately 3:00 AM when a male looked into the window of a friend's vehicle parked in her driveway.
