A 2011 Toyota Camry was reported stolen from the residence, and jewelry and electronics. Scene was processed. The vehicle will be entered into national database as stolen.

Burglary-Residential 92923-16/ Radcliffe Drive, Palm Coast /Zone 4/ V-1 reported her home was burglarized during the evacuation. Entry was made through a rear sliding glass door that was shattered. Various electronics were stolen. Scene was processed.
