Keyholder RP reported that she arrived at the business to check on it and found a rear door propped open. An initerior door showed signs of forced entry and two cash bags and petty cash were reported stolen from the business. The scene was processed for DNA.

CSI responded to process the scene. Call still active and and inventory list is being completed for national database entry.
