Fire Structure/ 17-103367/ Ryder Dr/ Sector 222 /Dryer caught fire in the garage. All occupants evacuated with no injuries. Fire was put out with minimal damage to structure. TOT FD. Deputy Picerne/Myers

Disturbance Physical/ 17-103378/ Parkview Dr/ Sector 225 /Two sisters, who live together in the same residence, involved in a physical altercation. S1 was determined to be the primary aggressor and was arrested for battery- domestic violence, and criminal mischief for the damage to the door. A subsequent search of S1's belongings revealed that she had a loaded handgun in her purse, but her concealed weapons permit expired in February 2017. Marijuana paraphernalia was also located in S1's purse; S1 was subsequently additionally charged with carrying a concealed firearm and possession of drug paraphernalia. Deputy Faircloth/Dawson

Larceny Shoplifter- Missing Juvenile Recovered/ 17-103401/ Palm Coast Pkwy SW (Kohls)/ Sector 215 /Four black male juveniles were observed entering Kohl's Department Store. 2 of them were observed by the LPO concealing jewelry and leaving the store without attempting to purchase the items. When confronted by the LPO, all four juveniles fled the area. They were located at Belle Terre Pkwy and Pine Lakes Pkwy South. It was discovered that all four are entered as missing juveniles out of Orange County, where they ran away from a group home they all lived at together. Deputy Petty and Deputy Petruzella/ Meehan.

Crash w/ Injuries/ 17-103409/ Old Kings Rd N/ Sector 216 /Head on collision between two vehicles. One female had to be extracted from vehicle. Transported to FHF with non-life threatening injuries. Roadway was closed at Oak Trails and Tuscan Reserve during extraction and vehicle removal. Deputy Olsen/Cavas

Disturbance w/ Weapons/ 17-103417/ Eton Ln/ Sector 226 /Multiple callers on Eton Ln advised that S1 was scratching and damaging their cars. She then retrieved a knife from within her residence and returned to the driveway telling the neighbors she was going to stab them. After several seconds of threatening numerous neighbors, S1 returned to her residence and closed the door. When contact was attempted with S1, she refused to answer the door but could be heard talking inside. A perimeter was established around the home and sworn statements were taken from all of the witnesses, verifying that a charge of aggravated assault was appropriate and learning that her son (approx.. 25 yoa) was also in the house. Contact was attempted over the phone on numerous occasions and PA announcements were made through the duration of the incident. After approximately 30 minutes of unsuccessful attempts to make contact with S1, she emerged through the front door and was taken into custody. S1 was charged with aggravated assault (6 counts) and criminal mischief and suffered no injuries. Report by Deputy Chambers.

Delayed Fraud/17-103391 Flagler Plaza Dr/ Sector 224 /Victim reported he had fallen victim of a "White Van Scam." On Tuesday, November 21, 2017 at approximately 12:00 PM, he was exiting the ACE hardware at 117 Flagler Plaza Drive, Palm Coast, when he was flagged down by two subjects in a white Dodge Grand Caravan (FL tag ELWI6). V1 stated that the subjects were two males, one white male and one black male, who were well dressed. They told him they had ordered too many home theater systems, and they were trying to sell the extras. Theater system was in what appeared to be a brand new, sealed box labeled "NRG Acoustics Professional Home Theater Systems".
