Disturbance Physical/ 17-105222/ Palm Harbor Village Way (Smiles)/ Sector 212 /Suspect (S1) followed her boyfriend to Smiles and saw him hanging out with another female, Victim (V1). S1 walked into the establishment and pushed V1, causing her to fall into a table and onto the ground. She did not sustain any visible injuries, but complained of a headache. Traffic Stop/ 17-105273/ Palm Coast Pkwy @ 195/ Sector 212 /Traffic stop conducted on southbound 195 on ramp. Driver was DWLS. A subsequent vehicle search located various narcotics and a firearm, which was confirmed stolen out of Duval County. Driver is also a convicted felon. Defendant arrested for numerous charges, including DWLS w/ knowledge, carrying a concealed firearm, possession of firearm by felon, grand theft of firearm, introduction of contraband, possession of heroin and possession of methamphetamine. Reckless Driver/ 17-105283/ Princess Rose Dr @ Princess Delores Ln/ Sector 225 / Units attempted a traffic stop on a vehicle on Belle Terre Pkwy. The vehicle was then located as it turned onto a cul-de-sac and another traffic stop was initiated. The vehicle now stopped and the driver was taken into custody. A search of the vehicle revealed evidence that suggested the driver may have discarded narcotics from the vehicle as he eluded law enforcement, but none were able to be located in the area.
