Crash w/injuries/96944-17/I-95 Northbound, south of Hwy 100/Sector 224 /A 3 vehicle crash occurred on Interstate 95 northbound resulting in minor injuries. The left lane of I-95 south of Hwy 100 was temporarily shut down for rescue's injury assessment. Nobody was transported to the hospital, but the incident caused traffic congestion. One party involved in the crash attempted to leave the scene, but was apprehended by Deputy Gaddie on I-95, north of Palm Coast Parkway. D-1, defendant, was arrested for leaving the scene of the crash and driving an unregistered vehicle. Crash report will be made.
