<p>Stolen Vehicle Recovered/ 17-93022 /Vehicle recovered in Daytona Beach at Brentwood Dr. Originally stolen from Flagler County. Vehicle removed from state and national databases as stolen. Tag and decal were previously recovered on November 2nd, 2017. Deputy Chambers.</p> <p>Stolen Vehicle/ 17-97448/Bowman Pl/ Sector 215 / Vehicle entered stolen state and national databases. Vehicle was left unlocked with the key in it and was stolen during the overnight hours. Deputy Petty.</p>

Stolen Vehicle/ 17-97466/ Enterprise Dr, Palm Coast/ Sector 221 /Vehicle stolen from the business parking lot between November 3rd at 3:30pm and November 6th at 9am. It was learned the vehicle was at the Capri Trailer Park. Deputies went to investigate and discovered D1 (defendant) asleep in the vehicle. D1 was awakened and refused Deputies commands. D1 started the vehicle and left at a high rate of speed, nearly striking a deputy. A perimeter was established, K9 and Fire Flight responded. The truck was located in the Z section. K9 and Deputies searched for D1. He was located and he was armed with a fixed blade knife and threatened Deputies. D1 refused commands and ran off jumping fences. On duty SWAT Team members responded. K9 was deployed with SWAT Team members. D1 was located in the woods by K9 and bitten. He was then taken into custody, and transported to FHF for treatment. D1 was subsequently charged with grand theft auto, resisting without violence, aggravated assault on LEO, fleeing and eluding and VOP (case #17-97598). Larceny/ 17-97488/ E SR 100 (Shell Gas Station)/ Sector 224 /Air-Vac machine was broken into and \$512.25 was taken from inside. Theft occurred between September 1st, 2017 and November 6th, 2017. Smoker's Express on Cypress Point Pkwy was also victimized under the same circumstances. Company representative advised that these thefts occur often in numerous states, but that these are the first known cases in Flagler County. Deputy Jurec
