Disturbance Domestic/111901-17/Essington Lane Palm Coast/Sector 226/ S1 was arrested for battering her boyfriend's mother, who is 81 years of age. S1, her boyfriend, and his mother all reside as a family within the home. S1 was charged with battery on person over 65 and transported to the FCIF for processing.

Traffic Stop/111862-17/I-95 Northbound, south of PC Pkwy/Sector 216/S1 was observed driving at a high rate of speed on Hwy 100 towards Interstate 95. S1 headed northbound on Interstate 95 continuing a reckless pattern, and was stopped by Sheriff Staly just south of the Palm Coast Parkway exit. Upon searching the vehicle, marijuana (under 20 grams) was found on

the passenger side floorboard. S1, the single occupant of the vehicle was arrested by the Sheriff for reckless driving and possession under 20 grams of marijuana. D-1's vehicle was removed by Roger's Towing.

VOP – Narcotics / 111868-17 / Weidner Place / Sector 221 / Dep. J. Smith was conducting a probation check on S1 with JPO. Upon arrival, S1, S2, and S2 were in a car parked in the roadway. S1 was instructed to get his mother from the residence. While S1 was making contact with his mother, narcotics were observed in and near the vehicle. S2 and S3 were detained and S1 was given lawful orders to return to the vehicle but he refused and stayed near the front door until backup arrived on scene and he was detained near the front door. While on scene, S1's mother and sister were very uncooperative. s1 was arrested for Obstruction and VOP. s2 and s2 were arrested for possession of cannabis under 20.
