Death/114809-17/Riverview Bend South 2021 Palm Coast/Sector 211/ Male discovered deceased by family members. Nothing suspicious observed.

Drunk Person / 22-18 / Palm Harbor Pkwy (European Village) / Sector 211 / S1 arrested for disorderly intoxication.

Fire Vehicle Passenger / 48-18 / I-95 NB MM 288/Sector 216/Vehicle caught on fire from mechanical issues (motor). All 3 occupants were able to exit the vehicle unharmed. One occupant was found to be carrying a concealed weapon without a concealed carry permit and a small baggie of marijuana. Charges included unlawfully CCW, destruction of evidence and possession of less than 20 grams of cannabis. The other two occupants were transported off the interstate without incident.

Disturbance Verbal –Battery on LEO / 50-18 / Ricker PL / Sector 222 / Units responded to the address twice for a verbal disturbance. While units were outside the residence preparing to leave the second time, residents advised that there was another disturbance. S1 became argumentative and tried to deny LEO entry even though a disturbance could be heard inside the residence and slammed the door on the deputies. He then became combative, grabbed a deputies pocket, and ripped his pocket off. S1 was placed under arrest.
