Follow-up/90524-2016/Essex Place Palm Coast/Sector 226/RP stated he found his firearm in his house that he previously reported stolen. The firearm that was originally reported stolen will be removed, supplement completed.

Trespass (after warning)/ 107400-17 / Auberry Drive / Sector 216 /Defendant (D1) was arrested and charged with trespass after warning and resisting without violence. See report by Deputy Ocampo.

Animal complaint/107432-17/ Slipper Orchid Trail Palm Coast/Sector 224 /While on patrol, Deputy Laverne and his trainee Deputy Taylor came across a stray dog. While attempting contact at a nearby home, another dog came from behind them while walking up to the front door and bit both deputies. Both were treated at FHF for minor injury. Report also made for animal control.

Narcotics / 107438-17 / Palm Coast Parkway NE / Sector 216 /Deputy Conway performed a traffic stop on a vehicle for running a red light. During a consent search, cannabis and a firearm were located near D1. D1 was on felony probation reference possession of cannabis with intent to sell. D1 was arrested and charged with possession of a firearm by a convicted felon, possession of ammunition by a convicted felon, possession of cannabis under 20 grams, possession of drug paraphernalia and felony VOP. See report by Deputy Conway.

Traffic Stop/107446-17/US1/Matanzas Parkway/Sector 213 /Deputy Malta conducted a traffic stop on a vehicle for a traffic infraction on US-1. Upon searching the vehicle, 11 clonazepam was found along with methamphetamine on a spoon and syringe. D-1 was arrested for possession of methamphetamine, possession of controlled substance, knowingly DWLSR, and possession of drug paraphernalia. D-1 was transported to the FCIF for processing.

Traffic Stop/107466-17Hwy 100 across Bulldog Drive/Sector 226 /Upon observing a traffic violation, units attempted a traffic stop and the vehicle fled. The vehicle was then located crashed into the woods across the street from Bulldog Drive. One occupant fled the scene into the woods and one was apprehended on Aviation Drive by Sergeant Weaver and Deputy Jacob and a female stayed inside the vehicle. A perimeter was established. K9 was called to the scene and the male was secured without incident by Corporal Gimbel. Inside the car, numerous narcotics and a firearm was found. D1 was found in the woods and was the driver of the vehicle where the firearm and narcotics were located and was a convicted felon. The other male, D2, had two warrants for his arrest for VOP burglary out of Osceola County and Orange County. All 3 subjects were from the Orlando area.
