<p>Battery LEO / 14499-18 / Florida Park Drive / 212 / While being secured for violation of injunction, S1 became combative and actively resisted law enforcement. During the course of attempting to secure S1, Deputy Conway suffered a dislocated shoulder and minor abrasions. S1 was able to be secured after an effective CEW deployment. After medical clearance at FHF S1 was transported to the detention facility and charged with violation of injunction, aggravated battery on law enforcement officer, and resisting arrest with violence. Due to Deputy Conway's injuries Deputy Bender completed 707 and Response to resistance.</p> <p>Burglary Commercial / 14578-18 / Palm Coast Pkwy NE 703 (T-Mobile) / Sector 212 / Units initially responded to a glass break alarm. Upon arrival the front door was located smashed using a stone paver. Multiple phones and other items were taken. Video shows a silver in color sedan pull in front of the store and two b/m's enter the front door after breaking the glass. Report made by Dep. Barnett.</p>
