Miami Dade PD asked FCSO to BOLO for a missing person believed to be in the area of Palm Coast Parkway and I-95. M1 was located in the cracker barrel parking lot, sitting in his vehicle. He was placed under a Baker Act without incident.

Deputies responded to a disturbance between O1 and his juvenile daughter. O1 stated that he was disciplining his daughter and things became physical between the both of them. The mother arrived on scene and witnessed the end of the disturbance. No medical attention needed. DV paperwork issued.

V1 called 911 and stated that his girlfriend, O1, punched him several times in the face and bit him. When deputies arrived, V1 showed them a black and blue saying it was a bit, but had no teeth marks. He also showed scratches on his neck area, but there were no marks on his face, where he said he was punched. V1 would not write out a written statement and did not want to file charges. O1 had her mother pick her up and she left for the night, with their 2YOA son.
