 S1 located by FBPD and arrested in reference to this case from yesterday on charges of fleeing and eluding and resisting arrest without violence.

Disturbance Domestic/ 18-11057/ N. Oceanshore Blvd/ Sector 111
 O1 called from the Kangaroo Gas Station to report that she had been in a physical disturbance with her boyfriend, O2. She stated that O2 threw a glass at her, which shattered on the floor, causing cuts to her arms and feet. She also stated that he took her cell phone from her when she was trying to leave and smashed it on the ground. Contact was made with O2 at the residence, who had pudding on his head and several small cuts to his forearms. He stated that O1 was intoxicated and threw pudding on him when he would not cuddle with her. She then threw the coffee pot in his direction, but it missed him and broke on the floor. Pudding was also located on the walls of the residence and O2's 16 year old daughter corroborated his side of the story. DV packets provided to both parties. O1 went to stay at her mother's house for the night and charges were submitted on both parties.

Disturbance Physical/ 18-11075/ Woodpecker Ln @ Cardinal Ln/ Sector 112

Neighbors called in a disturbance involving multiple combatants. Upon arrival, contact was made with V1, who advised that two males beat him when he knocked on their door looking for his girlfriend, O1. It was determined that S1 and S2 Became angry when V1 came to the door looking for O1. S1 threatened V1 with a knife and then used it to slash two tires on his vehicle. The two then battered V1, at one point holding him down and kicking him repeatedly in the head. S1 and S2 arrested for battery, aggravated assault, and criminal mischief and transported to FCIF. Narcotics were located in S2's shoes and he was additionally charged with possession and introduction of contraband.
