The female was pronounced deceased on scene, and the male was transported to FHF as he still had a pulse. Report made by Deputy Jacob.

Suicide / 55249-17 / Ryder Place, Palm Coast/ Sector 222/ 1 adult male found hanging inside of his bedroom closet. Multiple family members arrived on scene to assist the care taker. Report made by Deputy Kocorowski.

Warrant Service/55275-17/Bickford Drive, Palm Coast/Sector 214 / Male was transported to FHF for medical treatment. It was discovered the male had a warrant for "VODP REF FELONY BATTERY, NO BOND, PICK-UP FLORIDA ONLY SIGNED JUDGE HAMMRICK." Law enforcement guarded the male and contacted SAO regarding the status.
