Commercial Burglary/ 17-57704 and 17-57707/ 1230 and 1224 Palm Coast Pkwy SW/ Sector 215 /Caller stated that he was sleeping on the bench in front of Bealls and heard glass break nearby. While units were responding, the caller reported hearing more glass breaking. Upon arrival, units found the front doors of Subway and Five Star Pizza had both been broken with entry made to the business. While units cleared the businesses, the caller identified the suspect vehicle as it drove past the crime scene. Units attempted to stop the vehicle as it got onto 195 southbound. The vehicle initially stopped by the scale house, then took off continuing southbound. Units deployed stop sticks as the vehicle exited at SR 100 and the vehicle subsequently crashed into a retention pond at this intersection.
