Burglary Commercial (Follow-Up)/ 2017-57704/ Palm Coast Parkway/ Sector 215/ Dayshift took over the investigation from the burglary that occurred during the early morning hours. Several incidents from Jacksonville and St. Johns were believed to be related to this case due to the subjects matching the descriptions of the suspects provided from SJSO through video surveillance. The suspects and vehicle that were located matched the overall descriptions of the suspects in the video surveillance from both scenes. Rico Ransom was arrested for three local warrants (see below) and Johnnie Thomas was arrested for Fleeing and Eluding. See report by Deputy Stogdon for further.
