TS – Hit and Run- Police Vehicle Damage/ 2017-58029 / Fruitwood St. and Grove Street then Greentree St and Acorn Ave / Sector 312 / Dep. Beausoleil attempted a traffic stop at Fruitwood and Grove on a silver vehicle. The vehicle fled, Dep. Beausoleil did not pursue. Dep. Beausoleil then drove to the area of Oleander to see if the vehicle did go to that residence. Dep. Beausoleil was stopped at the Stop sign on Greentree at the intersection of Acorn when the vehicle came off Acorn, turning onto Greentree. The vehicle hit the front of Dep. Beausoleil's explorer, damaging the push bar and fender. This time Dep. Beausoleil was able to positively identify the driver, S1. S1 then fled the scene toward Butternut. Dep. Beausoleil turned around and attempted to catch the vehicle until he was told to cancel on Butternut. As he was advising he was canceling, the vehicle hit a tree/ditch at Butternut and Forest Park. FHP worked both crashes and cited S1 for leaving the scene with damage and Careless Driving. Dep. Beausoleil arrested S1 for DWLS (fel), Fleeing and Eluding and Reckless.
