Assist other agency/2017-73268/I-95/Sector 224 /Ormond Beach PD and VCSO advised that they were engaged in a pursuit of a vehicle. They stated that they were in bound to the county on I-95. They advised they had charges for Fleeing and Eluding and aggravated battery on LEO with the attempted strike of a vehicle. One tire was already stop stuck and the vehicle speed was 30 mph. FCSO pulled in behind the vehicle at SR 100 and S1 was landline with Dispatch. He was advised to pull over the vehicle without incident. Prior to the scales, the vehicle pulled to the right and a Felony stop was initiated on Suspect (S1). S1 was taken into custody and he had five active warrants that were confirmed. VCSO and OBPD had charges reference the Fleeing and Eluding also and they accompanied our unit to the Inmate Facility to complete paperwork. Three of the warrants were for Grand Theft out of St Johns County. The other two warrants were for VOP Battery and FTA. He was Booked into FCIF and then made statements of harming himself so he was placed under a Baker Act and transported to Halifax under a supervised condition to be evaluated.
