Suspicious Incident/17-66518/ Intracoastal Waterway (ICW)/ Sector 111 /A citizen reported seeing a fire on a 25ft boat in the middle of the ICW. The complainant advised the fire was out but the boat did not have power. Deputy S. Williams was working, so a boat was launched in the ICW. Deputies checked the ICW for the boat in question; however, it was not able to be located. Local fisherman reported seeing a boat towing another boat going southbound through the ICW. The two boat towing companies did not tow the described boat. It is possible the boat the fisherman saw being towed was the disabled boat, but it was not able to be confirmed who it was that towed the boat in and where the boat was towed to.

The Reporting Person (RP) advised that two (2) subjects opened her rear passenger door, displayed a gun and told her to give him her purse. Burglary Residential/ 17-66435/ Farraday Ln, Palm Coast / Sector 211 /V1 advised that on 8-5-17 at approximately 4:45P he returned home and found his house ransacked. At the time of the report V1 was unable to determine if anything was missing from the property however, he was provided an inventory sheet to fill out if he notices anything missing. Suicide attempt/ 17-66441/ Burning Bush, Palm Coast/ Sector 214/Bravo units responded to a report of a female who hanged herself in her garage, prior to the arrival of units the female's husband and son cut her down. Cpl. Reckenwald arrived on scene shortly thereafter and administered CPR until relieved by Rescue; female regained a pulse and was admitted into the ICU at FHF for further treatment. Domestic Disturbance/ 17-66539/ Palm Harbor, Palm Coast/ Sector 212 /V1 advised that S1 shoved her in the chest numerous times causing her to lose balance and hit the wall. V1 further stated that S1 grabbed her by the forearm and threw her to the ground. V1 had slight redness on her arms which was photographed. S1 was arrested for battery and transported to the inmate facility without incident. See report by Deputy Ray for further.

Drunk Driver/ 17-66567/ Port Echo Ln, Palm Coast/ Sector 225 /Units responded to a crash with no injury. Upon the completion of a crash investigation a DUI investigation was started. The driver and sole occupant of the vehicle was placed under arrest for DUI. He subsequently provided two breath samples, .122 and .121 respectfully.
