Burglary Residential/ 17-78828/ Red Barn Dr/ Sector 222 /FCSO assisted residents at this location in evacuating the residence this morning. A tree fell in the front yard and was lying on power lines. There was also structural damage to the roof. After the evacuation, the homeowner returned later to attempt to retrieve some belongings. When she arrived, she observed her next door neighbor inside her house wearing gloves. Apparent forced entry by breaking the

back sliding glass door. Large amount of jewelry missing. Suspect fled into his home and was apprehended a short time later. Investigation ongoing. Deputy West.
